A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA, AMENDING RESOLUTION NO. 2016-1517, RECLASSIFYING A PUBLIC WORKS INSPECTOR POSITION TO A SENIOR PUBLIC WORKS INSPECTOR, AND RECLASSIFYING A POSITION OF OFFICE ASSISTANT AND CREATING THE POSITION OF ASSISTANT TO THE CITY CLERK AND ESTABLISHING THE SALARY RANGE FOR SAID POSITION, EFFECTIVE APRIL 26, 2017.
