The applicant/architect and property owners joined the ARP members and staff at the project review table and identified themselves: Skyler Kogachi (applicant/architect), Mark Levine (designer), Eric and Daniella Brown (property owners).

Associate Planner Judie Gilli provided an overview of the project to the Panel. The architect, Skyler Kogachi, described the existing conditions and design of the proposed new house and style. The architect provided photos of the existing house and surrounding homes, and a colors/material sample board. The architect discussed the inspiration of the design for the homeowners. The panel stated that the proposed architectural style is consistent and compatible with the architectural evolution of new homes in the surrounding neighborhood, and appreciates the well designed contemporary style. The panel unanimously recommends approval of the design subject to the following recommendations: provide a more detailed landscape plans that includes plants to soften the front elevation, parapet roof color change from white to light gray, increase the thickness of cantilevered entry roof, the metal cap over the parapet shall match the color of the stucco, the louvered cantilevered awnings shall be thickened to make them more structurally substantial. Staff can confirm that the above changes were made to the final Planning Commission plan submittal.
