Judie Gilli, Associate Planner gave a brief history of the project to the panel members. The architect, Laura Hanson, described changes that were made since the August 23, 2019 ARP meeting. The panel asked questions of the project architect. The Panel commented that the revisions have addressed all the Panel's previous comments, but made the following friendly suggestions:

- 1. Consider eliminating use of the brick around the trash area (to save cost)
- 2. Detail the brick edges so that they are capped or trimmed

With the above friendly suggestions, the panel recommended approval of the revised project.
