Associate Planner Magana summarized the project. The applicant, Mark Leaf, answered questions from the Panel. The Panel liked the design of the proposed sign, and asked if it will be illuminated. The applicant stated that they will install two LED up lights. The Panel is okay with up lighting, as long as it will only illuminate the sign and not spill beyond the letters. The lights should be the same copper color, or matte black, finish to match the letters. Finally, the lighting shall comply with the City's dark skies ordinance and use a warmer light temperature. The Panel voted unanimously to recommend approval of the project with the above mentioned recommendations.

Administrative Plan Review, Sign Permit and Scenic Corridor Permit for new signage and an exterior modification to an existing dealership (Volvo) located at 24400 Calabasas Road, in the Commercial Retail (CR) zoning district and the Calabasas Bicycle Master Plan. The Panel asked the architect to provide details and specification of the proposed signs, and more information about the monument sign. The Panel asked about the durability of painting aluminum panels, and to provide the Panel with the color manufacturer and number. The Panel requested that the architect update the color rendering to include landscaping and walls, and to provide a night time rendering. Finally, the Panel suggested that the architect consider incorporating the "white" color in other elements of the building. The Panel voted to continue the item to the next meeting in order to let the architect provide additional information requested by the Panel.
