# **TASK FORCE REPORTS**

Councilmember Shapiro reported his participation in a Valley Economic Alliance (VAE) Board meeting. The VAE has expressed interest in making a presentation to the City Council in the near future. Additionally, he reported attendance to a Legislative, Communication and Membership Committee meeting. Further, he reported that the SCAG's General Assembly would be hosted virtually on May 6. Lastly, he reported that the Price School at USC is holding two separate meetings in June regarding planning post-pandemic and housing and transportation.

Councilmember Kraut reported that Councilmember Weintraub and he attended a Headwaters Corner meeting with the Tree People. Demolition of the Bartel House will take place on May 10 and the bridge should be finalized by the end of June. Starting June 1, they will be holding bi-weekly volunteer events. Public access should begin on June 15.

Councilmember Weintraub added that Headwaters Corner conducted outreach to the schools; and they received great feedback from Science teachers at Calabasas High School. She further reported that the COG will be streamlining how legislation is brought back to members of the City Council. In addition, she reported that speeding on Mulholland Highway has picked up again, and expressed appreciation to the Lost Hills Sheriff's Deputies who will be patrolling the area.

Mayor pro Tem Maurer reported that in addition to the COG, they also receive legislation support from the various entities the City Council represents. In addition, she reported that the Santa Monica Mountains Conservancy received \$12 million for wild fire recovery and prevention. The 101 corridor from Calabasas up to Ventura is considered one of highest-hazard zones with direct pathways to Malibu. She will report back as to what projects the funds will be applied to.

Mayor Bozajian reported that Councilmember Kraut and he met with Calabasas Chamber of Commerce representatives; and at the May 26 Council meeting, one of the main items will be consideration of use of some of the stimulus funds to assist the Chamber.

# CITY MANAGER'S REPORT

Mr. Meik reported that staff is scheduled to return to City Hall on May 3, with 35 percent of staff fully vaccinated, which will increase after the second dose clinic at the AHCCC on May 7. Next step would be to fully reopen to the public and a discussion with the Council about meetings.
