## Dear Members of our City Council,

I have been a resident of Calabasas for 14 years. In the last 2 years I have seen a dramatic increase of homeless people in our neighborhood; making my family and myself feel unsafe. Last summer, a homeless man broke into a vacant home on my street and resided there for several days until a neighbor saw him outside. The police came and dropped him off less than a mile away where he robbed a CVS. To live in Calabasas and feel that I can't have my daughter walk to our local school bus stop is completely unacceptable.

Additionally, I am an employee at a retail store in the Commons. Over the last year we have had to call security half a dozen times to have homeless people who were refusing to wear a mask and acting belligerent removed from the store. Obviously this is bad for our business and it makes residents and visitors in our community feel vulnerable and extremely uneasy. I do not know the details of the proposed ordinance, but I do know that something needs to be done so that our city doesn't become like some other parts of the valley. Thank you for your time.

When my family moved here from Woodland Hills, my children were 3 and 5 yrs old. Moving my young children to this community was the best and singly most impactful decision that my wife and I have made toward their well being. It is with this in mind that I feel compelled to write you regarding Ordinance No. 2021-394.

Politics aside it's hard to debate the fact that our state and county has seen a rapid deterioration in the of quality of life tied to the number of unhoused forced to camp on the streets of Los Angeles. It does not have to be this way in our amazing city.

From Venice to Woodland Hills, we have failed these citizens living on the streets, as well as the impacted local residents and families in these communities.

Everyone suffers when homelessness is unmanaged. Communicable diseases, such as COVID-19, "diabetes, heart disease, and HIV/AIDS are found at high rates among the homeless population, sometimes three to six times higher than that of the general population (www.endhomelessness.org, 2021).

We owe it to all of our residents, housed and unhoused to not follow in the failed footsteps of our neighboring municipalities.

By working with the local Sheriffs to offer transportation, a warm bed and meal at a nearby shelter, we are taking responsibility for the problem, as well as maintaining Calabasas as the special place that it is.

First, as a Calabasas resident, I want to thank you for your representation and the work you do on behalf of our beautiful city.

In reviewing the City Council Meeting Agenda for this evening, I noticed Agenda Item # 11 A & B.

I am writing on both matters and to express my support for:

1) entering into a contract for interim housing and support services for unhoused persons

-and-

2) Support for Ordinance No. 2021-394, adding Calabasas Municipal Code Chapter 9.38 "Use of the Public Rights of Way and Protection of Schoolchildren, Bus Stops, Critical Infrastructure and Wildlife Areas," and Adoption of Resolutions designating Critical Infrastructure and School Routes

I am supporting both initiatives above because I believe in doing our best to offer real and compassionate help for those experiencing hardship, while also recognizing that our city and its residents need to be prioritized and protected too—for physical safety, health safety and fire safety.

Over the past couple of years, I have witnessed a significant increase in activity in our community that is cause for concern, including public defecation on more than one occasion just below the patio of King's Fish House, a dispute between two unhoused men taking place in both directions of traffic in front of the fire station, people camping/living in the dry brush dense hillsides throughout our city, etc.

The encampment that is growing daily just east of our city— west of Fallbrook on Ventura Blvd— is an illuminating example of a tragic and untenable situation for everyone involved — the surrounding businesses, homeowners, pedestrians and

the unhoused and the addicted people living in the encampments. No one is thriving in that current environment and in fact, it is just the opposite. We need to be concerned for those who are struggling by offering real help, but we also need to be concerned for our businesses who are struggling to survive post-Covid (and who are still required to pay taxes) and the surrounding homeowners who are also being adversely affected.

I sincerely hope that the Calabasas City Council will do both for our city—offer interim help for those who need it, but if refused, protect the public spaces and rights of way and the interests of the residents and business owners of our city.

Hello,

Thank you for your time & research with offering services to support our unhoused population in Calabasas.

I am a human rights activist in LA County and one of our growing focuses we support is advocating for our unhoused population from street sweeps in the larger populated cities in LA County.

I generally sit in on every city council meeting to stay in touch with what is happening in our city but find that I have never felt the need to raise my hand or write in.

This particular topic caught my attention & I took myself off mute without much preparation but wanted to write in & communicate that it is our due diligence to offer extensive wraparound services & options before criminalizing the unhoused.

Here are some top line public comments I would like to ensure I communicate:

- 1. I would like to propose the city hire a city social worker as our needs are projected to grow.
- 2. I would like to propose a social worker/non-sheriff employee respond to unhoused calls.
- 3. I would like to propose we establish a safe parking lot area.
- 4. I would like to propose we contract beds to support unhoused citizens experiencing mental health/substance abuse concerns.
- 5. I would like to propose contracting services to support unhoused citizens that are not experiencing mental health/substance abuse concerns but are experiencing financial hardship.
- 6. I would like to propose lowering violation penalty fine maximum & adding additional attempts from 1 request to a minimum of 5 requests before the unhoused citizen is detained by the Sheriff if no other crime is being committed.

I look forward to problem solving this together as a community so the both the housed and unhoused citizens of Calabasas are supported in living a comfortable life.
