Consideration of a Planning Commission Resolution recommending to the City Council: 1) certification of the Final Environmental Impact Report (EIR); 2) adoption of the 2021-2029 Housing Element update and associated Land Use Element updates to the Calabasas 2030 General Plan, consistent with statutory requirements of California Housing Element law; and, 3) adoption of Ordinance No. 2021-395 amending Title 17 of the Calabasas Municipal Code by adding new Sections 17.18.060 and 17.22.050, creating an "Affordable Housing Overlay Zone" and associated development standards for qualifying housing development projects; amending other sections within Title 17 of the CMC as necessary to be consistent with the added new sections; and updating the official zoning map; all as necessary to conform with the General Plan Housing Element and related updates. Pursuant to the California Environmental Quality Act (CEQA), an Environmental Impact Report (EIR) has been prepared and circulated in compliance with CEQA and the CEQA Guidelines.
