ESTABLISH NEW BANK ACCOUNT FOR THE AHCCC BY ADOPTING RESOLUTION NO. 2022-03 AN AMENDMENT TO THE RESOLUTION NO. 2019-08 AUTHORIZING SIGNATORIES FOR THE AHCCC JPA BANK ACCOUNT AND AUTHORIZE INVESTMENT OF MONIES IN THE LOCAL AGENCY INVESTMENT FUND BY ADOPTING RESOLUTION NO. 2022-04

The Agoura Hills/Calabasas Community Center (AHCCC) has a bank account established at Bank of America. When the bank account was established, it was listed as an association, and not a government agency. This has created several problems for the AHCCC, including the inability to delete signatories, and add current ones, and to have the money collateralized.

The Federal Deposit Insurance Corporation (FDIC) insures money in the bank up to \$250,000. Banks must collateralize all monies above that amount held in government agency bank accounts. Because the AHCCC account is not listed as a governmental account, amounts held over \$250,000 are currently not collateralized. Since the bank account has not been above the \$250,000 mark in the past few years, this has not been a concern. However, with the receipt of the recent grant, and the need to deposit funds into the bank, this needs to be urgently addressed.

Furthermore, because the account was opened as an association, signatories are listed as primary shareholders, and cannot be removed. In 2019, the AHCCC passed a resolution authorizing the two City Managers and two Finance Directors to be signatories. To date, staff has been unable to adjust the signatures, and the only current signatories assisting the AHCCC are the two current Finance Directors. Although numerous attempts have been made to adjust the signatures, the bank branches have been closed and unable to assist.

Staff is therefore recommending that the AHCCC open a new bank account. The two cities work with Wells Fargo and Bank of America, so quotes were requested from both banks. Bank of

America declined to provide a quote. They have been transitioning away from small governmental accounts. The following information can be summarized below:

The attached Pro Forma details other charges that will be applied. The earnings allowance is the amount of interest that will be credited towards any fees. It is recommended that Wells Fargo be selected as the new bank for the AHCCC.

In order to set-up the bank account, Resolution 2022-xx needs to be adopted. Establishing the current officers as signatories and allowing for their successors to replace them. Additionally, Resolution 2022-xx must be adopted establishing authorized officers to deposit and withdraw monies from the Local Agency Investment Fund (LAIF). Although the AHCCC currently has a LAIF account, it was established prior to the requirement to have an authorizing resolution.

RECOMMENDATION

- 1. Establish a new bank account with Wells Fargo
- 2. Adopt Resolution 2022-03 an amendment to the Resolution No. 2019-08 authorizing signatories for the AHCCC JPA bank account
- 3. Authorize investment of monies in the Local Agency Investment Fund by Adopting Resolution 2022-04
