

RESOLUTION NO. 97-426

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON MARCH 4, 1997, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW.

WHEREAS, a General Municipal Election was held and conducted in the City of Calabasas, California, on Tuesday, March 4, 1997, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 96-419 adopted December 11, 1996, the City Clerk canvassed the returns of the election and has certified the results are received, attached and made a part hereof as "Exhibit A."

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except absent voter ballots and provisional ballots was 2,100;

That the whole number of absent voter ballots cast in the City was 776, the whole number of provisional ballots cast in the City was 11, making a total of 2,887 ballots cast in the City.

SECTION 2. That the names of persons voted for at the election for Member of the City Council are as follows:

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective

offices for which the persons were candidates are as listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that:


James Robert Bozajian, Lesley Devine and Robert Sibilia were elected as Member of the City Council for the full term of four years.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing:

- (1) The whole number of ballots cast in the City; and
- (2) The names of the persons voted for; and
- (3) For what office each person was voted for; and
- (4) The number of votes given at each precinct to each person; and
- (6) The total number of votes given to each person.


SECTION 6. The City Clerk shall certify as to the adoption of this resolution and shall cause the same to be processed in the manner required by law.


