RE: Recommended Approvals for Wireless Facilities Applications

1. Site ID: CLL02043 (WTFM-2022-005) 24403 Mulholland Hwy:

The City of Calabasas (the “City”) requested that Telecom Law Firm, PC (“TLF”) review the Applicant’s application submitted on behalf of AT&T Mobility (“AT&T”) to modify its existing wireless site mounted to a wood utility pole located in the Public Right-of-Way located near 24403 Mulholland Highway.

TLF recommends that City move this project forward to the approval process. This project appears to be one that qualifies for Section 6409(a), because the proposed modification does not result in a substantial change. Accordingly, this project is subject to a 60-day shot clock.

This project appears to adhere to the Tier 2 standards of City’s Municipal Code (“CMC”) §17.31.050. AT&T through its vendor has provided the ‘certified-under-penalty-of-perjury’ RF compliance statement as required by the CMC§17.31.040(D)(10).

2. Site ID: CLU2027 (WTFM-2022-006) 27001 Agoura Rd:

The City requested that TLF review the Applicant’s application submitted on behalf of AT&T to modify its existing wireless site mounted to the rooftop of a building located at 27001 Agoura Road.

TLF recommends that City move this project forward to the approval process. This project appears to be one that qualifies for Section 6409(a), because the proposed modification does not result in a substantial change. Accordingly, this project is subject to a 60-day shot clock.

This project appears to adhere to the Tier 1 standards of the CMC §17.31.040. AT&T through its vendor has provided the ‘certified-under-penalty-of-perjury’ RF compliance statement as required by the CMC §17.31.040(D)(10).

3. Site ID: CLL02011 (WTFM-2022-008) 4280 Valmar Road:

The City requested that TLF review the Applicant's application submitted on behalf of AT&T to modify its existing wireless site mounted to a wood utility pole located in the Public Right-of-Way located near 4280 Valmar Road.

TLF recommends that City move this project forward to the approval process. This project appears to be one that qualifies for Section 6409(a), because the proposed modification does not result in a substantial change. Accordingly, this project is subject to a 60-day shot clock.

This project appears to adhere to the Tier 2 standards of the CMC §17.31.050. AT&T through its vendor has provided the 'certified-under-penalty-of-perjury' RF compliance statement as required by the CMC §17.31.040(D)(10).

4. Site ID: CLU2026 (WTFM-2022-009) 4937 Las Virgenes Road.

The City requested that TLF review the Applicant's application submitted on behalf of AT&T to modify its existing wireless site mounted within the cupola of a building located at 4937 Las Virgenes Road.

TLF recommends that City move this project forward to the approval process. This project appears to be one that qualifies for Section 6409(a), because the proposed modification does not result in a substantial change. Accordingly, this project is subject to a 60-day shot clock.

This project appears to adhere to the Tier 1 standards of the CMC §17.31.040. AT&T through its vendor has provided the 'certified-under-penalty-of-perjury' RF compliance statement as required by the CMC §17.31.040(D)(10).

5. Site ID: Lost Hills (WTFM-2022-010) 26791 Agoura Road:

The City requested that TLF review the Applicant's application submitted on behalf of Verizon Wireless ("Verizon") to modify its existing wireless site mounted on the rooftop a building located at 26791 Agoura Road.

TLF recommends that City move this project forward to the approval process. This project appears to be one that qualifies for Section 6409(a), because the proposed modification does not result in a substantial change. Accordingly, this project is subject to a 60-day shot clock.

6. Site ID: CLU2012 (WTF-2022-0001) 23945 Calabasas Road:

TLF recommends that City move this project forward to the approval process. This project appears to be one that qualifies for Section 6409(a), because the proposed modification does not result in a substantial change. Accordingly, this project is subject to a 60-day shot clock.
