SUMMARY RECOMMENDATION:

As in previous years, it is recommended that the City Council adopt Resolution No. 2022-1817 recognizing October as Bullying Awareness Prevention Month in the City of Calabasas.

BACKGROUND:

The Bullying Awareness Prevention campaign is held during the month of October and unites communities nationwide to educate and raise awareness of bullying prevention. National Bullying Prevention Awareness Month is recognized in communities across the United States, with hundreds of schools and organizations signing on as partners.

National Bullying Awareness Prevention was developed in response to the need to raise awareness of bullying, as it was historically viewed "a childhood rite of passage" and believed that bullying "made kids tougher", when the reality is that bullying has devastating effects such as school avoidance, loss of self-esteem, increased anxiety, and depression.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA, RECOGNIZING OCTOBER AS BULLYING PREVENTION AWARENESS MONTH IN THE CITY OF CALABASAS.

WHEREAS, school bullying involves someone or a group of individuals harming another by: hitting or threatening (physical), teasing and name calling (verbal), spreading rumors, hurting someone's reputation or excluding someone (social isolation), using online and social media platforms to support deliberate, repeated and hostile behavior that is intended to harm another (cyber bullying); and

WHEREAS, bullying occurs in neighborhoods, playgrounds, schools, and through technology, such as the Internet and cell phones; and

WHEREAS, various researchers have concluded that bullying is the most common form of violence, affecting millions of American children and adolescents annually; and

WHEREAS, thousands of California children and adolescents are affected by bullying annually; and

WHEREAS, targets of bullying are more likely to acquire physical, emotional, and learning problems and students who are repeatedly bullied often fear such activities as riding the bus, going to school, and attending community activities; and

WHEREAS, children who bully are at greater risk of engaging in more serious violent behaviors; and

WHEREAS, children who witness bullying often feel less secure, more fearful, and intimidated; and

WHEREAS, the City of Calabasas supports the Bullying Prevention Awareness efforts in the City by the Las Virgenes Unified School District, as well as through other organizations; and

WHEREAS, the City of Calabasas supports programs throughout the City to teach, educate, encourage and enlighten all our citizens on the positive ways to treat one another as well as the positive ways to enjoy our lives; and

WHEREAS, the City of Calabasas wishes to raise awareness in our community of this serious problem.

NOW, THEREFORE, BE IT RESOLVED that the Calabasas City Council hereby supports and recognizes October as Bullying Awareness Prevention Month in the City of Calabasas.

The City Clerk shall certify to the adoption of this resolution and shall cause the same to be processed in the manner required by law.

SUMMARY RECOMMENDATION:

Staff recommends that City Council adopt Resolution No. 2022-1816 to approve an agreement for sharing cost of state highway electrical facilities between the City of Calabasas and State of California Department of Transportation.

BACKGROUND:

The City of Calabasas has had an agreement with the State of California Department of Transportation to share the cost of maintaining all electrical facilities at the intersections with any state highway route since January 6th, 1993. The current agreement does not include the new added intersections at Lost Hills/ 101 Hwy Southbound & Calabasas Road/101 Fwy Southbound.

DISCUSSION/ANALYSIS:

The new agreement is similar to the previous agreement where the City of Calabasas is sharing the costs with the state of California through the Department of

Transportation of the operating and maintenance of all electrical facilities at the intersections with any state highway route within the City of Calabasas. These facilities include the flashing beacons, traffic-signals, and traffic-signal systems, safety-lighting and sign-lighting. The agreement would include two additional locations that were not included in the existing agreement. The share cost distribution would be as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA APPROVING THE AGREEMENT FOR COST SHARING OF STATE HIGHWAY ELECTRICAL FACILITIES IN THE CITY OF CALABASAS.

WHEREAS, the State of California, acting by and through its Department of Transportation has presented an Agreement for cost sharing of State highway electrical facilities in the City of Calabasas effective as of September 28, 2022, and to remain in effect until amended or terminated; and

WHEREAS, Streets and Highways Code section 130 requires a municipality to adopt a resolution for any money appropriated for the acquisition of rights of way for the construction, improvement or maintenance of county highways, city streets, or joint highway district roads;

WHEREAS, the City has read said Agreement in full and is familiar with contents thereof:

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CALABASAS, that said Agreement for cost sharing of State highway electrical facilities in the City attached hereto as Exhibit A is hereby approved and the Mayor, City Manager and City Clerk are directed to sign the same on behalf of the City.

AGREEMENT FOR SHARING COST OF STATE HIGHWAY ELECTRICAL FACILITIES WITH CITY OF CALABASAS

THIS AGREEMENT is made effective this	day of	, 2022, by and between
the State of California, acting by and through	the Department of	Transportation, hereinafte
referred to as "STATE" and the CITY of CALA	ABASAS, hereinafter	referred to as "CITY" and
collectively referred to as "PARTIES"		

This Agreement shall supersede any previous Agreement and/or Amendments thereto for sharing State-incurred costs with the CITY.

The cost of operating and maintaining flashing-beacons traffic-signals, traffic-signal systems, safety-lighting, and sign-lighting now in place at the intersection of any State Highway Route and any CITY street/road shall be shared as shown in Exhibit "A".

NOW THEREFORE IT IS AGREED:

- 1. Basis for Billing:
 - 1.1. It is agreed that monthly billings for flashing-beacons, traffic-signals, and traffic-signal systems shall be based on actual intersection costs, which are as follows:
 - 1.1.1. Maintenance Labor, including overhead assessment, other expenses including, equipment, materials, and miscellaneous expenses
 - 1.1.2. Electrical energy
 - 1.2. It is agreed that quarterly billings for safety-lighting and sign-lighting shall be based on calculated unit-costs derived by averaging STATE's District-wide costs each quarter. Costs are as follows:
 - 1.2.1. Maintenance Labor, including overhead assessment, other expenses including, equipment, materials, and miscellaneous expenses
 - 1.2.2. Electrical energy
 - 1.3. It is agreed that quarterly billings invoiced to CITY for STATE- owned and maintained electrical facilities identified in Exhibit "A" will be based on actual costs paid by STATE, when derived from utility company billings. STATE will bill CITY quarterly in arrears for any CITY share of electrical facilities expenses shown in Exhibit "A".
- 2. Exhibit "A" will be amended, as necessary by written concurrence of both parties, to reflect changes to the system.

3. STATE costs and expenses assumed under the terms of this Agreement are conditioned upon the passage of the annual State of California Budget by the Legislature, the allocation of funding by the California Transportation Commission as appropriate, and the encumbrance of funding to the District Office of STATE to pay the billings by CITY.

4. LEGAL RELATIONS AND RESPONSIBILITIES

- 4.1. Nothing within the provisions of this Agreement is intended to create duties or obligations to or rights in third parties not PARTIES to this Agreement or to affect the legal liability of a PARTY to the Agreement by imposing any standard of care with respect to the operation and maintenance of STATE highways and local facilities different from the standard of care imposed by law.
- 4.2. Neither CITY nor any officer or employee thereof is responsible for any injury, damage or liability occurring by reason of anything done or omitted to be done by STATE, under or in connection with any work, authority or jurisdiction conferred upon STATE arising under this Agreement. It is understood and agreed that STATE shall fully defend, indemnify and save harmless CITY and all of their officers and employees from all claims, suits or actions of every name, kind and description brought forth under, including, but not limited to, tortuous, contractual, inverse condemnation and other theories or assertions of liability occurring by reason of anything done or omitted to be done by STATE under this Agreement with exception of those actions of STATE necessary to cure a noticed default on the part of the CITY.
- 4.3. Neither STATE nor any officer or employee thereof is responsible for any injury, damage or liability occurring by reason of anything done or omitted to be done by CITY under or in connection with any work, authority or jurisdiction conferred upon CITY and arising under this Agreement. It is understood and agreed that CITY shall fully defend, indemnify and save harmless STATE and all of its officers and employees from all claims, suits or actions of every name, kind and description brought forth under, including, but not limited to, tortuous, contractual, inverse condemnation or other theories or assertions of liability occurring by reason of anything done or omitted to be done by CITY under this Agreement.
- 5. TERMINATION This Agreement may be terminated by timely mutual written consent by PARTIES; by either party upon thirty (30) days' notice to the other party.
- 6. TERM OF AGREEMENT This Agreement shall become effective on the date first shown on its face sheet and shall remain in full force and effect until amended or terminated at any time upon mutual consent of the PARTIES or until terminated by STATE for cause.

PARTIES are empowered by Streets and Highways Code Section 114 and 130 to enter into this Agreement and have delegated to the undersigned the authority to execute this Agreement on behalf of the respective agencies and covenants to have followed all the necessary legal requirements to validly execute this Agreement.

REPORT:

Pursuant to AB 361, which went into effect on October 1, 2021, at their October 13 meeting the City Council adopted Resolution No. 2021-1751, authorizing remote teleconferencing meetings so long as the City Council complies with certain requirements. Determinations by the City Council that the emergency affects the ability to meet safely in person must be renewed every 30 days.

Staff contacted other LA cities to inquire how their meetings are being handled. Summary of cities that responded are listed below. 27 cities are conducting in-person meetings; 24 cities are conducting hybrid meetings and six cities are still fully remote.
