- File No. WTFM-2022-012:** A request for a Wireless Telecommunication Facility Minor Modification Permit for the collocation of Dish Wireless at an existing wireless facility in accordance with Section 6409(a) of the 2012 Middle Class Tax Relief act. The applicant is proposing the installation of panel antennas onto the rooftop of an existing three-story office building, with all new equipment and antennas screened from view behind screen walls to match the existing building. The subject site is located at 27001 Agoura Rd (APN: 2064-004-066) within the Commercial Business Park (CB) zoning district and Scenic Corridor (-SC) overlay zone. The City's staff has determined that the project is exempt from environmental review in accordance with Section 21084 of the California Environmental Quality Act (CEQA) and Section 15301 (Existing Facilities) of the CEQA Guidelines.
