Introduction:

This sign program consists of five sign type categories:

Site Identification
Tenant Identification
Wayfinding
Regulatory Signs
Parking Garage Identification

All signs support rebranding of the project with the new name, 4500 Park Granada.

Site Identification signs consist of ST1 Primary Monument Sign and ST2 Secondary Monument Sign. ST1 Primary Monument Sign and ST2 Secondary Monument Sign replace existing signs with new design consistent with rebranding of project. Please refer to corresponding sheets for details on design and construction of signs.

The building owner is responsible for construction and installation of Site Identification signs listed above. Tenant names are the responsibility of the Tenant unless a different agreement is reached between the Landlord and the Tenant.

Tenant Identification signs include ST3 Tenant ID Sign - On Wall and ST4 Tenant Sign at Annex Building. These signs are intended to provide notification of tenant's existence on the property and/or in a specific building to both pedestrian and vehicular traffic. Tenant Identification is also inlcuded in ST1 Primary Monument Sign which includes 8 Tenant names. Tenant Identification sign locations are limited to ST1 Primary Monument and on building (ST3 Tenant ID Sign - On Wall and ST4 Tenant Sign at Annex Building) in designated locations as described herein. Tenant names that are allowed on building and/or the Primary Monument Sign are based on separate criteria established by the Landlord and documented in the Tenant's lease agreement.

All Tenant Identification signage must comply with the criteria herein and is subject to Owner approval prior to permit application.

All signs are within the property line and do not impact the Right-of-Way.

Design Requirements:

1. General Criteria

The following guidelines apply to all tenant signage. All signage shall be designed to comply with criteria listed in their correspondings sheets.

2. Design Review Process, Permits

All construction documents for signage, permanent or temporary, must be reviewed and approved by an authorized agent of the Building Owner prior to submittal to local governing agencies for review and permitting.

Fees and expenses related to the design, permitting, fabrication and installation shall be the responsibility of the tenant. Fabrication and installation must be by a Landlord approved company.

Upon termination of the lease and/or vacating the premises, tenant shall be responsible for the removal of their name and the repair of the wall, unless the requirement is waived by the Landlord in writing. Removal must be performed by a Landlord approved company.

3. Exhibits

The exhibits shown along with text are included to aid in interpreting the intent of these guidelines. Together the text and exhibits describe the number, size, location, colors, and types of materials approved for signs in this project.

4. Allowable Messages

The content of tenant's signage shall be limited to the tenant's trade name or logotype. Descriptive words used to define the type of business (IE. COTY Professional Beauty instead of just COTY) may be permitted with Landlord approval. Logo-marks and corporate identity elements are prohibited.

5. Number of Signs Visible from the Street

Where Tenant is allowed signage, their name may only appear once on ST1 Primary Monument Sign and once on each Buildings they occupy if they are the primary tenant in the building. The specific location a Tenant is allowed to have signage is based on separate criteria established by the Landlord and documented in the Tenant's lease agreement. Tenant's name may appear on additional signage as needed for wayfinding so long as Landlord approves of the design prior to fabrication and the sign is entirely upon the property and not visible from the public right-of way.

6. Sign Sizes

Refer to specific sign type sheets.

Design Requirements:


- 1. The location of signs shall be only as shown on the Sign Location sheet of this document and any additional criteria listed on sign type sheets.
- 2. All electrical signs shall bear the UL Label and the installation must comply with all local building and electrical codes.
- 3. Exposed conduit and/or raceways are prohibited.
- 4. All conductors, transformers, and other related equipment shall be concealed.
- 5. All sign fastenings, bolts, and clips shall be galvanized iron, stainless steel, aluminum, brass, or bronze or black iron of any type. Fastenings may be required to be painted.
- 6. Location of all penetrations in the walls of the buildings for conduit and/or mounting studs shall be indicated in the review and permit package.
- 7. No sign-makers labels or other indentification will be permitted on the exposed surface of signs, except those required by ordinance. Required labels shall be located in an inconspicuous location.
- 8. Signs installed by the Tenant must be maintained in a new or 'almost new' conditional at the expense of the Tenant.

MAXIMUM NUMBER One

LOCATION At the main vehicular entrance to the project.

SIGN COPY Project name and up to 8 tenant names. Brand names

and info which makes sign appear to be an advertise-

ment, such as ® and TM are prohibited.

SIDES Single-sided

MAX SIGN AREA & SIZE See sheet 1.1 for breakdown of areas for sign area and

sign copy area. The maximum square footage of sign structure shall be 100 ft². The maximum square footage

of sign copy shall be 50 ft².

SIGN CONSTRUCTION Smooth, durable, non-weathering sign. All hardware

shall be of nonferrous metals. Sign copy permitted to be

push-thru, flat cut out, or channel letters.

ILLUMINATION 3000K LED illumination is permitted. Face and edge

illumination of 4500 logo is permitted. The words Park Granada are permitted to be push-thru acrylic with edge illumination and opaque faces. Push-thru acrylic with face and edge illumination are permitted for tenant names. Tenant panel background to remain opaque. Exposed neon lighting, conduit, and raceways are

prohibited.

LOGO/LOGOTYPE Permitted, if approved by the landlord.




















