ORDINANCE NO. 2004-196

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA, ESTABLISHING SALARIES FOR MEMBERS OF THE CITY COUNCIL.

THE CITY COUNCIL FOR THE CITY OF CALABASAS DOES ORDAIN AS FOLLOWS:

Section 1. Section 2.04.090 of the Calabasas Municipal Code is hereby amended to read as follows:

"2.04.090 Councilmember--Salary.

Each member of the City Council shall receive as salary the sum of *five hundred* sixty six dollars (\$566.00) per month, as prescribed in Section 36516 of the California Government Code for cities up to and including thirty-five thousand (35,000) in population."

<u>Section 2.</u> Pursuant to Government Code Section 36516.5, this ordinance shall take effect on the first day of the month following the date a councilmember begins a new term of office following the 2005 General Municipal Election.

<u>Section 3.</u> The Mayor shall sign this Ordinance and the City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be processed in the manner required by law.
