 File No. SPR-2022-006 (Continued from 04/20/23): Request for a Site Plan Review to construct a 1,833 square-foot addition to the existing two-story single-family residence located at 5222 Dantes View (APN: 2052-030-024) within the Residential Single-Family (RS) zoning district. Commissioner Lia recused himself from the project because he lives within 500 feet of the subject property.

3. Review of the 2023-2024 Capital Improvement Program (CIP) for General Plan Consistency.

The Commission asked questions of City Planner Bartlett and Director Klein. City Planner Bartlett and Director Klein clarified that the Commission's role in the Capital Improvement Program review is to ensure that items listed in the program are consistent with the General Plan.

Following discussion by the Planning Commission, Commissioner Mueller moved, seconded by Commissioner Lia, in finding the Capital Improvement Program is consistent with the General Plan with the additional language below to be reflected in the minutes and forwarded to the City Council:

"The Planning Commission finds the proposed 2023/24 – 2027/28 Capital Improvements Program to be consistent with the policies and programs of the Calabasas 2030 General Plan; however, the Commission recommends that the City Council carefully review the merits and costs associated with two projects:

1) Furniture Replacement for the Civic Center Plaza; and, 2) the West Calabasas Road Improvements (particularly a proposed roundabout at the intersection of Calabasas Road and Mureau Road)."
