2. <u>File No. SPR-2022-005:</u> Request for a Site Plan Review to construct a 1,008 square-foot addition at the rear of the residence, an 18 square-foot addition at the entryway, and a net conversion of 7 square feet of garage space into habitable space at the existing one-story single-family residence located at 26223 Hatmor Dr (APN: 2052-016-004) within the Residential Single-Family (RS) zoning district.

New Business:

3. Consideration of modification(s) to the City's Story Pole requirements for a proposed mixed-use project located at 4799 Commons Way.

Director Klein made a presentation to the Commission via a Power Point presentation.

Chris Robertson, Applicant, made a presentation to the Commission via a Power Point presentation. In her presentation Ms. Robertson requested to modify the story pole requirements for the mixed use project proposed at the Calabasas Commons, to allow for an alternate approach utilizing augmented reality technology.

Ms. Robertson outlined that in addition to the augmented reality technology, kiosks would be installed throughout the center providing additional information and the Commons would host a series of community tours to demonstrate the technology and discuss the project.

Following further discussion, it was agreed that the Applicant would return to the Planning Commission with the following information:

Provide more information with regard to augmented reality.

Provide more information about billboards and kiosks to be installed throughout the Commons

Explore further the ability to install at least partial physical representation utilizing story poles or some other design.

If the applicant finds that no poles are feasible, then provide a detailed justification of why poles can not be safely installed.

4. Discussion of Fire Safety and Resilience Code Standards

Director Klein made a presentation to the Commission and highlighted the request from the City Council that the Planning Commission review the current fire safety codes and resiliency standards. He outlined what goes into a project or development review through the process of how various fire standards are implemented.

In addition to Director Klein, City Building Official Sparky Cohen and City Plan Check Consultant, Robert Woodward answered Commissioners' questions.

The Commission outlined a list of recommendations for Council consideration. Director Klein confirmed that the Commission's recommendations would be placed on a future agenda for the City Council to discuss.

Director Klein stated that the July 6th meeting would be cancelled unless the story pole item is ready to proceed to the July 6th meeting of the Planning Commission.
