1. A presentation on Adaptive Reuse by Roberto Vazquez, Project Director at Omgivning.

Mr. Vazquez, Project Director of Omgiving, an architectural and interior design firm, that specializes in adaptive reuse projects, made a presentation to the Planning Commission.

Adaptive reuse projects focus on taking existing underutilized properties or buildings and converting them to a new purpose, such as increasing the housing supply.

Public Hearing Item(s):

4. File No. SPR No. 2022-013; SCP 2022-002; OTP 2023-009: Request for a Site Plan Review, Scenic Corridor Permit, and Oak Tree Permit for encroachment into the protected zone of oak trees to construct a two-story, 1,512 square-foot addition at the rear of an existing two-story single-family residence located at 24325 Mulholland Hwy (APN: 4455-045-008) within the Hillside Mountainous (HM) zoning district and Scenic Corridor (-SC) overlay zone.

Planner Rackerby made a presentation regarding the project utilizing a Power Point presentation.

Reports by the Director and Planning Commission:

5. Director's Report: Discussion of Planning Commission Resolutions.

Director Klein stated there is a public hearing item scheduled before the Planning Commission on September 21st. He also announced that one or two youth members of the Mayors Youth Council may be selected to be liaisons to the Planning Commission.

Additionally, he announced it is the last meeting with Deputy City Attorney Margolin. The Director thanked him for his work on the Commission and behind the scenes.

Director Klein discussed two paths the Commission could take in the process of resolution approval or denial.

The first path is to include in the staff report a resolution with staff analysis of the project and staff's recommendation for approval or denial.

The second path would include staff taking a more neutral stance and include an overview and analysis of the project in the staff report but not include a recommendation. Once a decision is reached, Commissioners would call for a resolution to be prepared by staff and brought to the next scheduled meeting for signature. It was discussed that a consequence of choosing the second path was that it entails an unnecessary delay to approval of projects.

After further discussion, Director Klein discussed that staff would take the Commissioners comments into account and evaluate a process that makes the most sense, moving forward.
