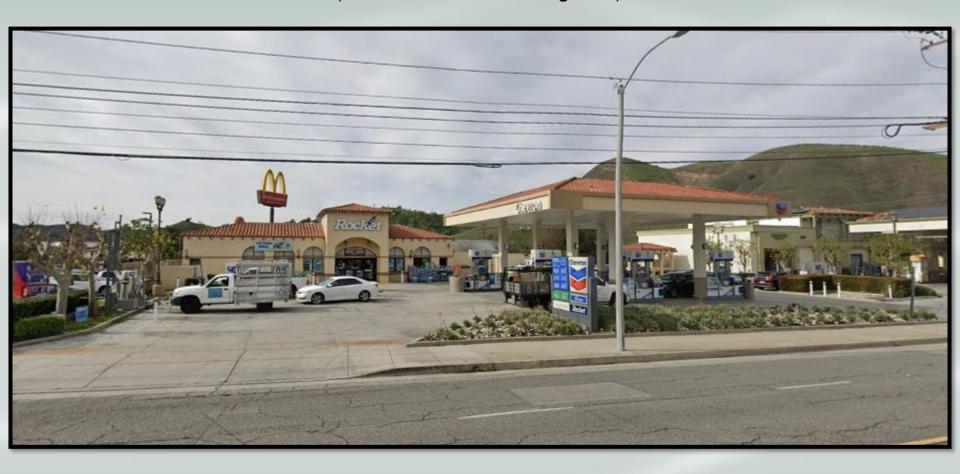
# Project Description and Applicable Code

- The Applicant requests a Conditional Use Permit to allow sales of beer and wine (already permitted under a prior CUP), and now spirits as well, via a Type 21 liquor license, at an existing convenience store/gas station.
- Calabasas Municipal Code section 17.11.020 includes alcohol sales as a conditionally permitted use in the CR zone.
- CMC Section 17.62.060 requires Conditional Use Permit requests to be reviewed by the Planning Commission.

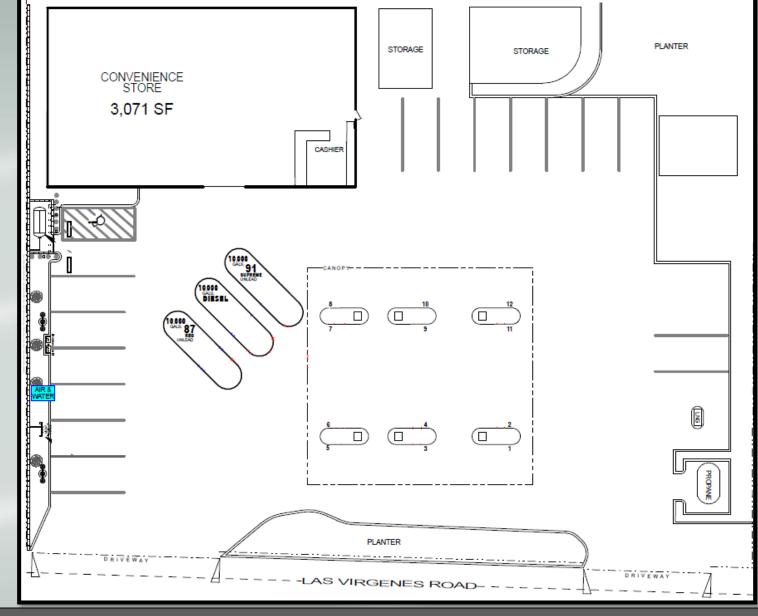

## Alcohol Sales at Subject Location

- Existing store operates 24 hours a day; available products include beer and wine, as permitted under a prior CUP.
- Sale of alcohol is limited to hours specified in State law (currently prohibited between 2:00 a.m. and 6:00 a.m.).
- Six alcohol display areas are proposed (2.7% of the sales floor).
- No changes to the exterior of the building.
- The store currently has two to three employees per shift, all of whom receive training for security policies and procedures related to alcohol sales.

# Required CUP Findings

- The proposed use is conditionally permitted within the subject zoning district and complies with all of the applicable provisions of this development code;
- The proposed use is consistent with the General Plan and any applicable specific plan or master plan;
- The approval of the conditional use permit for the proposed use is in compliance with the California Environmental Quality Act (CEQA); and
- The location and operating characteristics of the proposed use are compatible with the existing and anticipated future land uses in the vicinity.



Request for a Conditional Use Permit to allow sale of beer, wine, and spirits for offsite consumption via a Type 21 liquor license from the State Department of Alcoholic Beverage Control in conjunction with the operation of an existing convenience store.

### Staff Conclusions

- The proposed project will not alter the existing convenience store/gas station use of the subject site, which is conditionally permitted in the CR zoning district.
- The project is exempt from CEQA review in accordance with Section 15061 (b)(3) (General Rule Exemption) and Section 15301 (Existing Facilities).



### Recommended Action

That the Commission direct Staff to develop findings in support of approval or denial of the project.

Note: A resolution of denial must include an explanation as to why at least one of the required findings for a Conditional Use Permit cannot be made.
