#### II. NOTEWORTHY INCIDENTS

A robbery attempt was reported on Calabasas Road. The victim was walking towards his vehicle in the parking lot when two male adults approached him. One of the suspects pointed a handgun at the victim and demanded his wallet and watch. The victim managed to escape and did not give any of his belongings to the suspects. The suspects fled the scene in a white BMW. (23-05117)

A burglary attempt was made at Mulholland Highway. The video surveillance captured a male adult climbing up the stairs to the second floor located at the back of the school building. The suspect attempted to enter the building by pulling on the door handles and was unsuccessful in gaining entry. This same building was burglarized two weeks prior. (23-04565, 23-04886)

A vehicle burglary occurred at Park Granada. Video surveillance captured four male adults making entry into a vehicle and stealing a coin purse containing change.

A neighbor at Park Casino reported their video surveillance footage captured the same suspects walking through their backyard. The suspects went down a hill towards the golf course and out of view. A backpack and handbag were discovered in bushes by a second neighbor at Park Casino.

## LOST HILLS JUVENILE INTERVENTION UNIT ACTIVITY REPORT FOR SEPTEMBER 2023 CALABASAS

#### SCHOOL ISSUES

- Safety Plan and Protocols meeting at LVUSD District Office.
- Conducted safety walk-through at Calabasas PAEC regarding safety procedures, camera systems, lock-up procedures, Knox Boxes, and communication procedures.
- We aided Calabasas High School for the PSA project and had a meeting at the Calabasas City Hall.
- We Assisted Calabasas High School regarding a cannabis sales case and a rumored gun on campus.
- Conducted Critical Scenario tabletop exercise with staff members at AE Wright Middle School & Chaparral Elementary School.
- Assisted Viewpoint School regarding a child abuse allegation.

#### **INTERVENTIONS**

Diversion & citation appointment with a Calabasas High School student and parents regarding cannabis sales.

Assisted AE Wright MS student regarding the possible distribution of inappropriate self-images. Counseled a student at AC Stelle MS regarding ongoing inappropriate text/social media communication.

#### **COMMUNITY / CRIMINAL ISSUES**

- 1. The Juvenile Intervention Team spoke with numerous parents and concerned citizens regarding juvenile issues in the community. Additionally, we provided parents with resources available in the community.
- 2. We inquired with the Sylmar Juvenile Court District Attorney regarding the investigation and filing of criminal charges against juvenile offenders.
- 3. Throughout the month we met with Captain Jennifer Seetoo to keep her up to date regarding our unit's investigations and current juvenile issues within the city.
- 4. We enrolled juveniles into the Youth Diversion Program for various violations.
- 5. The Juvenile Intervention team investigated, prepared, and filed cases with the District Attorney's office. Additionally assisted other investigators in the preparation of cases for court.
- 6. We collaborated with station narcotic detectives in tackling drug-related issues among juveniles in our community. Through exchanging information, we developed effective strategies that will help us address problems and make our community a safer place for everyone.
- 7. Handled the processing and follow-up of various juvenile referrals brought to the attention of this unit for various juvenile contacts with uniform personnel.
- 8. Conducted normal checks of juvenile problem areas in the city during weekends and evenings. Additionally responded to juvenile-related calls for service.
- 9. Assisted patrol regarding CARP, backfilled behind patrol shortages and worked mandatory overtime
- 10. Assisted Calabasas High School regarding security and crowd control at football games.
