Hello Lindsay,

I have gone over what you sent me and you are correct we should only be using the index from August 2022 to August 2023. That shows an increase of only 3.3%. So the monthly rate would increase from \$9,044.92 to \$9,343.40 As far as when the rate would go into effect I believe we are looking at November 1st. I do not have a copy of the last extension in my office but the original contract was up in November so I can only assume the extension is as well. I can verify this with Rick when he gets back from vacation but I know you needed this ASAP. If this is agreeable to you I can authorize this and override Rick on this one. Hello Michael,

This is the email that Rick sent regarding the new monthly rate and the attachment for the CPI increase.

In order to finalize Amendment No. 3 to the PSA that extends the contract one year and increases the total contract amount, we need some clarification on how the new monthly rate and CPI of 7.6% was determined. Specifically, the time span being January 2022 to August 2023 since

the monthly invoice was increased in August 2022 from \$8,328.66 to \$9,044.92.

When would the new monthly rate of \$9,732.33 go into effect? Could you please send a clear breakdown of the calculations so we can see how everything was calculated to arrive at the new rate and CPI % and the new monthly invoice rate?
