

Would you say that things in the City of Calabasas are generally headed in the right direction or do you feel that things are off on the wrong track?






Voters are mostly uncertain of whether cannabis sales are legal or not in Calabasas.

If you don't know, you can tell me that instead.






Views on Legalizing Retail Cannabis in Calabasas

A majority oppose allowing retail cannabis businesses within city limits.

However, the City of Calabasas is considering lifting the current ban and allowing for cannabis retail stores. 




Views on Cannabis Rules and Regulations

I am going to mention different rules and regulations that may be included if retail cannabis businesses were allowed to legally operate within Calabasas city limits.








Split-Sample Presentation of Supportive and Opposing Statements

Do you generally support or oppose allowing retail cannabis businesses within Calabasas city limits?






Segmenting the Electorate

- Consistent Support: Voters who consistently indicated they would support the measure
- Consistent Oppose: Voters who consistently indicated they would oppose the measure
- Swing: Voters who do not fall into any of the other categories – remaining consistently undecided or switching positions

The following slide shows demographic groups that *disproportionately* fall into one category or the other.





Conclusions

Conclusions

- Calabasas voters are largely unfamiliar with whether cannabis retail sales are currently allowed within city limits.
- However, a majority oppose lifting the ban on retail cannabis sales.
- If cannabis were to be legalized for one reason or another, voters offer strong support for a number of the rules and regulations for cannabis businesses, particularly distance requirements from children's facilities and testing products for contaminants.
- After providing reasons to support and oppose lifting the ban on retail cannabis sales within city limits, the results indicate that, at this time, Calabasas voters are not open to this idea.
