He also noted that the ACM recruitment closes on November 10.

Mayor pro Tem Weintraub thanked staff for doing an amazing job at the last PSPS event. Mr. Meik shared that Public Safety did a great job by checking on

residents with special needs.

Mr. Lanzafame reported that Public Works staff would be available in case of

any emergencies.
