Glenn:

I like mix-use housing and grew up in Parkchester, Bronx N.Y. which has stores (including Macy's) restaurants, bowling alleys and medical and dental offices throughout the development. (We didn't call it a "project".) We were a family of five with one car that we used only a few times a month.

However, the development was built during WW II and didn't make provision for cars, so we parked in the surrounding neighborhood. I've seen mixed-use projects in D.C. and think they are great.

I'm not a NIMBY person. Converting the Common's into a mixed use project won't work. Most of Calabasas depends on automobiles to get to the Commons. I don't think the project was designed to take parking an increased traffic into account. (Over the 38 years I've live on Park Belmonte in Calabasas, the traffic has become a problem-- especially traffic jams caused by people using Calabasas Road -- the main entrance to the new apartment -- as an alternate to the jammed 101.) As you know we have lots of school in and near Calabasas. School traffic -- especially high school traffic, where many students have their own cars -- is a problem. (I try not to use city streets between 8 and 9 am and 2 to 4am.)

Thank you again for taking the time to talk to me. My apologies for my near- endless monologue, but at the end of the telephone call and think we understood each other.

I have a some questions (which I would think are key to your review of the Commons Lane project):

1. When was the Commons project approved? **December 17, 1997**
  
2. When was the Commons project completed? **1998 per Assessor's Office**
  
3. When it was completed, how many parking spaces did it have? **The number of parking spaces on the project site currently is most relevant for project review purposes. We have not yet completed staff reviews of the site conditions, application materials, and project plans to accurately determine the appropriate number of spaces to serve the future demand of the proposed project. A specific analysis is in process, but has not yet been completed.**
  
4. Today, how may parking spaces does it have? **1,059 spaces per the submitted project plans on City's website (<https://www.cityofcalabasas.com/our-city/current-projects/the-commons-lane>)**
  
5. If approved, how many above-ground parking space will the Commons have? **See Sheet G001 on project plans (<https://www.cityofcalabasas.com/our-city/current-projects/the-commons-lane>), keeping in mind that the number may change as the project is revised in response to staff review comments.**
  
6. What was the population of Calabasas when the Commons was approved (and completed)? **Do not have that information readily available. Check with the California Department of Finance website for historical demographic information <https://dof.ca.gov/reports/demographic-reports/>**
  
7. What is the population today? **<https://www.cityofcalabasas.com/our-city/about-us/demographic-information>**

8. How many households did Calabasas have when the Commons was approved (and completed)? <https://dof.ca.gov/reports/demographic-reports/>

9. How many households does Calabasas have today? <https://www.cityofcalabasas.com/our-city/about-us/demographic-information>

10. What will the population of Calabasas be after the Commons Lane and Park apartments are both completed. Per the plans on file, proposed units are 119 for Commons Lane project and 107 units for Park Apartments project, for a total of 226 new housing units. At 2.71 persons per household (household size per U.S. census Bureau), approximately 613 persons would be added

11. How many households will Calabasas have when both projects are completed? See #9 and #10 above

11. How many above ground-parking spaces will be eliminated to build the Park Apartments? Their property currently has 125 spaces. As to your question, we're not sure yet because the project application is currently incomplete and subject to revision.

Also, I'd like to learn more regarding the requirements for affordable housing units and how the city plans to meet those requirements. The California Housing Defense Fund (“CalHDF”) submits this letter to remind the Commission of its obligation to abide by all relevant state housing laws when evaluating the proposed mixed-use development project with 119 total units, including 12 affordable units, at 4799 Commons Way. The Housing Accountability Act (Gov. Code § 65589.5; the “HAA”) requires approval of zoning and general plan compliant housing development projects unless findings can be made regarding specific, objective, written health and safety hazards. The HAA also bars cities from imposing conditions on the approval of such projects that would reduce the project’s density unless, again, such written findings are made.

The proposed development utilizes the California State Density Bonus Law (Gov. Code § 65915; the “DBL”). It seeks DBL concessions/waivers of development standards with respect to (1) parking stall dimensions and (2) building height. The City must grant these concessions/waivers unless it can make certain findings on which it bears the burden of proof. These concessions/waivers, moreover, do not render the project noncompliant with the local zoning code and general plan for HAA purposes. (Gov. Code § 65589.5(j)(3).) The HAA’s protections therefore apply, and the City must not reject the project, except based on health and safety standards, as outlined above.

As you are well aware, California remains in the throes of a statewide crisis-level housing shortage. New housing such as this is a public benefit; it will bring increased tax revenue and new customers to local businesses, and it will reduce displacement of existing residents. It will also help cut down on transportation-related greenhouse gas emissions by providing

housing in denser, more urban areas, as opposed to farther-flung regions in the state (and out of state). While no one project will solve the statewide housing crisis, the proposed development at 4799 Commons Way is a step in the right direction. CalHDF urges the Planning Commission to approve it, consistent with its obligations under state law.

CalHDF is a 501(c)3 non-profit corporation whose mission includes advocating for increased access to housing for Californians at all income levels, including low-income households. You may learn more about CalHDF at [www.calhdf.org](http://www.calhdf.org).
