2. Adoption of Resolution 2023-782, approving File No. SPR-2020-002; consistent with the Commission's direction on November 2, 2023.

Add to the resolution a new condition which states:

The Applicant shall have a waterproofing plan prepared by a licensed contractor with waterproofing expertise, and such waterproofing plan shall be submitted to the City Engineer for approval before issuance of any grading or building permits; and, Applicant shall implement the waterproofing plan as approved to the satisfaction of the City Engineer.

Additionally, the Commission directed that all legal issues regarding ownership be resolved and also any issues with regard to offsite grading.

File No. 2023-008: Request for a Site Plan Review to construct a 945 square-foot addition to an existing two-story single-family residence located at 4051 Magna Carta Rd (APN: 2079-013-014) within the Residential Single-Family (RS) zoning district.

Planner Rackerby presented the staff report and Power Point presentation for the project.

The request is to allow for a 7 ft. side setback e to expand the first level kitchen.
