**PUBLIC SAFETY & EMERGENCY PREPAREDNESS REPORT**

**COMMUNITY EMERGENCY RESPONSE TEAM (CERT)**

The CERT program is being reviewed to determine how to proceed. CERT by-laws and organization have been developed and are being reviewed by Public Safety Commission committee members. The fire department has a new format for the training class, and schedule will be announced this month.

**CRIME PREVENTION SYMPOSIUM**

Public Safety staff has been meeting with the various speakers in preparation for the 2/12/24 presentation. See attached flyer and agenda for details.

**CONTINUITY OF OPERATIONS PLAN (COOP)**

Public Safety is continuing to meet with MRG Consulting to work on the Continuity of Operations Plan (COOP). We have been working with individual departments on completing a workbook that identifies essential functions, notifications and ongoing communications, support & resource requirements and continuity facilities.

**MOBILE EOC STATUS**

The mobile EOC trailer is expected to arrive in February. Training will be scheduled with staff after the arrival.

**AUTOMATED LICENSE PLATE READER (ALPR) CAMERAS**

Thirteen additional ALPR cameras were approved by the City Council on October 11, 2023. The cameras were installed in December 2023. More ALPR camera sites are being evaluated.

**SMMC FIRE GRANT**

Staff is continuing to work on the Santa Monica Mountains Conservancy grant. With the additional funds, the Resident Emergency Preparedness Guide will be updated and Chipper Day Program will be developed.

**TRAINING**

Annual Emergency Operations Center (EOC) training exercise for city staff and EPIC Communications personnel are scheduled for June 4, 5 and 6, 2024. More to follow.

**FEMA**

FEMA project updates for the January through March Winter Storms are as follows:

Jan storms: Debris removal is currently "Pending Environmental Planning and Historic Preservation Review". Emergency Protective Measures has been funded.

Feb/March storms: The McCoy Creek Slope project at the Tennis & Swim Center parking lot is currently at "Pending Consolidated Resource Center Project Development" and is going through a formal eligibility review.

**HAZARD MITIGATION PLAN**

Public Safety staff is continuing to work on the Las Virgenes/Malibu Council of Governments Multi-Jurisdictional Hazard Mitigation Plan (MJHMP). The final draft MJHMP is on the city's website for public comment and review. The Plan will be submitted to Cal OES on February 1, 2024 for review before going to FEMA for final review.
