SCHOOL ISSUES

- Assisted Chaparral Elementary regarding a teacher under the influence, and possession of alcohol on school campus.
- Assisted Calabasas High School regarding a report of a possible firearm brandishing by a Calabasas student during trick or treating in the Calabasas neighborhood.
- Assisted AE Wright Middle School regarding a student in possession of cannabis on school grounds.
- Assisted Calabasas High school regarding a student report of possible inappropriate interactions and video content with another student.
- LVUSD students on Thanksgiving Break

INTERVENTIONS

- Counseled a student at AC Stelle Middle School for bullying another student at Lindero Canyon Middle School.
- Assisted an AE Wright Middle School parent regarding a student in a treatment facility out of state for rehabilitation.

COMMUNITY / CRIMINAL ISSUES

1. We spoke with numerous citizens and parents who called to question various juvenile concerns and issues in the community, they were provided with resource programs within our community.
2. We inquired with the Sylmar Juvenile Court District Attorney regarding the investigation and filing of criminal charges against juvenile offenders.
3. Met with Captain Jennifer Seetoo throughout the month to keep her up to date regarding our unit's investigations and current juvenile issues within our city.
4. Entered juveniles into the Youth Diversion Program for various violations.
5. We investigated, prepared, and filed cases with the District Attorney's office. We additionally assisted other investigators in the preparation of cases for court.
6. Met with station narcotic detectives to exchange information regarding juvenile and drug related issues.
7. Handled the processing and follow-up of various juvenile referrals brought to the attention of this unit for various juvenile contacts with uniform personnel.
8. Conducted our normal checks of juvenile problem areas in the city during weekend evenings and responded to juvenile related calls for service.
9. Assisted patrol regarding CARP, backfilled behind patrol shortages and worked mandatory overtime.
10. Attended Calabasas High School Audio Visual Class PSA presentation regarding dangers of inappropriate social media use.

11. Contacted LVUSD schools to consult on strategic placement of Knox Boxes.
12. Attended the Calabasas youth council meeting at City Hall and presented current LVUSD school issues regarding fighting, bullying, and inappropriate social media use.
13. Conducted a “Tobacco Sting” operation in the city of Calabasas for illegal nicotine product sales to persons under 21 years old.
14. Conducted staff critical incident scenario exercise with round Meadow staff.



SCHOOL ISSUES

- The J-Team assisted Calabasas High School in dealing with an incident related to the distribution of obscene material.
- Assisted Calabasas High School regarding a TikTok post containing student pictures.
- LVUSD was on winter break.

INTERVENTIONS

The J-Team counseled a Calabasas High student and parent regarding the possession of a knife on campus. The J-Team responded to the residence of AE Wright Middle School student regarding a suspension over a non-viable threat. The student and parent were receptive to counseling.

COMMUNITY / CRIMINAL ISSUES

1. The J-Team spoke with numerous citizens and parents who had concerns about various juvenile issues in the community. We also provided parents with information on resource programs available in our community.
2. The J-Team contacted the Sylmar Juvenile Court District Attorney to inquire about the investigation and filing of criminal charges against juvenile offenders.
3. The J-Team kept Captain Jennifer Seetoo informed about our unit's investigations and current juvenile issues in the city through regular meetings throughout the month.
4. The J-Team entered juveniles into the Youth Diversion Program for various violations.
5. The J-Team conducted investigations, prepared cases, and filed them with the District Attorney's office. Additionally, we supported other investigators in preparing cases for court..
6. The J-Team met with station narcotic detectives to exchange information regarding juvenile and drug-related issues.
7. Our unit processed and followed up on various juvenile referrals related to contacts with uniformed personnel.
8. The J-Team conducted the normal checks of juvenile problem areas in the city during weekend evenings and responded to juvenile-related calls for service.
9. The J-Team assisted patrol regarding CARP, patrol shortages, and worked mandatory overtime.

10. The J-Team attended a Calabasas High School Audio Visual Class PSA presentation regarding the dangers of inappropriate social media use.
