Historic Preservation Officer Bartlett responded to questions about the follow-up historic resources survey; he stated that the focused survey approach recommended by the Commission has not yet been related to the Department Dirtector and City Manager, but that he will take care of this within the next few weeks. Mr. Bartlett advised the Commission that for the next meeting the annual CLG report will be forthcoming, and possibly a sign permit for another new business in Old Town Calabasas. Mr. Bartlett further reported that the City Council had recently approved the Old Town banners, including not only the regular "Old Town Calabasas" designs that had been recommended by the HPC, but also several special event banner styles (e.g., for the Pumpkin Festival and 4th of July).
