Notice of Intent to Adopt a Mitigated Negative Declaration

NOTICE IS HEREBY GIVEN that the City of Calabasas has completed an Initial Study for the following project in accordance with the City's Guidelines implementing the California Environmental Quality Act:

Project Title: Mulholland Highway Safety Improvements Project

Project Location: The Project site is considered the public right-of-way and adjacent areas

along Mulholland Highway from the southern City limit generally northward to a point approximately 700 feet northeast of the Old Topanga

Canyon Road West intersection.

Project Description: The Project consists of improvements to approximately 2.4 miles of

Mullholland Highway, including widening the road shoulder, realigning the roadway centerline as needed to provide wider shoulders, slope grading to prevent erosion, slope stabilization improvements, a retaining wall and intersection improvements. All improvements would be located within the public right-of-way along Mulholland Highway or within existing slope easements, except new or expanded slope easements would be required for the following parcels to accommodate penetration of soil nails to be used for slope stabilization: APNs 4455-004-046, 4455-049-004, 4455-006-

008, 2069-013-016 and 2069-016-038.

Project Proponent: City of Calabasas Public Works Department

An Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. On the basis of such Initial Study, the City's staff has concluded that the project will not have a significant effect on the environment and has, therefore, prepared a Draft Mitigated Negative Declaration.

The Initial Study reflects the independent judgement of the City. The project site \square is, \square is not, on a list compiled pursuant to Government Code section 65962.5. The proposed project \square is not, considered a project of statewide, regional or area wide significance. The proposed project \square will, \square will not, affect highways or other facilities under the jurisdiction of the State Department of Transportation.

All comments received related to issues discussed in the IS/MND will be included in the final package that is forwarded to City of Calabasas Planning Commission and the City Council for further consideration.

A public hearing for the City of Calabasas Planning Commission and City Council to receive comments on the IS/MND and to adopt the IS/MND will be scheduled and noticed at a later date.
