GRAND PRIX (Ages 5-7) For the younger tennis player getting started, Grand Prix is a 45-minute class that introduces and develops basic tennis skills and technique in a fun-filled and engaging environment. Grand Prix practice is held on USTA approved 8 and under courts which are smaller in size so students can learn the rules on a court fundamentally appropriate for their age/skill. The tennis balls (orange dot) used for this level have a lower bounce and do not move as fast so they are easier to hit, allowing students time to get to the ball and promoting optimal swing patterns. **Monday, Wednesday and Thursday - 4:30-5:15pm or 5:15-6:00pm**

**Assumption of the Risk and Waiver of Liability Relating to

The undersigned hereby agrees to defend, indemnify, and hold harmless the City of Calabasas and its officers, employees and agents from and against any and all loss, liability charges and expenses (including attorney's fees) and cost which may arise by reason of participation in any program. (The City does not provide accident, medical, liability, workers' compensation insurance or any other insurance for program participants). As parent/guardian, I hereby consent to emergency treatment of my minor child as a result of accident or injury. I further agree to pay any and all costs incurred as a result of said treatment. I understand the City retains the right to use photos taken during activities for publicity purposes.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing. All participants in recreational activities must comply with all safety and preventative measures put in place by the City to reduce the spread of COVID-19. Safety measures are subject to change or revision in accordance with state and local guidance.

By signing this agreement, I represent that I will adhere to all the applicable COVID-19 preventive measures required by the City of Calabasas and other applicable governments. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the City, its employees, agents, and representatives. This release does not include any claims based on the gross negligence of the City, its employees, agents, and representatives.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Top Seed Summer Camp or participation in Camp Activities ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless **Top Seed Tennis Academy**, and the City of Calabasas, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
