II. NOTEWORTHY INCIDENTS

On March 18 at 2130 hours, a male adult Calabasas resident was arrested for domestic violence on Ruthwood Drive.

On March 16 at 1925 hours, a residential burglary occurred on Park Ora. A downstairs sliding door was smashed to make entry into the residence. A laptop computer was taken.

On March 15 between 1730 and 2200 hours, a residential burglary occurred on Dry Canyon Cold Creek Road. Entry was made through an unlocked door. The property did not have an alarm or cameras. Jewelry and cash were taken.

A male adult was observed shoplifting in the late night hours from a gas station on Las Virgenes Road. The suspect was located by Deputies a short time later, on Mureau Road and arrested for the theft.

A female adult was arrested for vandalism after an argument with a neighbor near Lost Hills Road and Las Virgenes Road. The suspect took her neighbors cell phone and attempted to flush it down the toilet.

A male adult was arrested for recklessly causing a fire near the intersection of De Berry Dr and Dantes View Dr. The suspect flicked a lit cigarette into dry brush, burning approximately $\frac{1}{2}$ acre.



ACTIVITY REPORT FOR MARCH 2024
CALABASAS**

SCHOOL ISSUES

The J-Team attended the School Absence Review Board (SARB) with LVUSD at the district office. Additionally, the J-Team conducted a critical scenario training for school staff at AE Wright Middle School.

INTERVENTIONS

The J-Team booked a juvenile involved in a retail theft investigation at Calabasas Sephora by appointment. The juvenile was charged and released on a citation to their parents.

The J-team booked an AE Wright student by appointment for a battery case with injuries. The juvenile was charged and released to their parents on a citation.

COMMUNITY / CRIMINAL ISSUES

1. The J-Team spoke with numerous citizens and parents who called to question juvenile concerns and community issues. We also provided the parents with resource programs within our community.
2. The J-Team contacted the Sylmar Juvenile Court District Attorney to inquire about the investigation and filing of criminal charges against juvenile offenders.
3. Throughout the month, we met with Captain Jennifer Seetoo to inform her about our unit's investigations and current issues involving juveniles in our city.
4. The J-Team entered juveniles into the Youth Diversion Program for various violations.
5. The J-Team assisted other investigators in preparing court cases and investigated, prepared, and filed cases with the District Attorney's office.
6. The J-Team met with station narcotic detectives to exchange information regarding juvenile and drug-related issues.
7. The J-Team handled the processing and follow-up of various juvenile referrals regarding various juvenile contacts with uniform personnel brought to the attention of this unit.
8. The J-Team conducted normal checks of juvenile problem areas in the city during weekend evenings and responded to juvenile-related calls for service.
9. The J-Team aided in patrolling for CARP, filled in for any patrol shortages, and worked mandatory overtime.

10. The J-Team verified the residences of 290 sex offenders within the Calabasas jurisdiction.
11. The J-Team attended an Event Action Plan (EAP) training at Lost Hills Station.
12. The J-Team attended AC Stelle Middle School regarding All America Boys Q&A with students.
13. The J-Team attended Chaparral Elementary TK, Kindergarten, and 1st grade classes to speak with students regarding safety.
14. The J-Team assisted in conducting a Tobacco Sting Operation for the city of Calabasas.
