1. Approval of meeting minutes: April 18, 2024

2. Adoption of Resolution 2024-788, approving File No. SPR-2023-016, OTP-2024-004, consistent with Planning Commission direction on April 18, 2024.

Discussion Item(s):

Discuss and Provide Recommendations for consideration by the City Council regarding the following General Plan Housing Element Implementation Programs: 1) Pre-Approved plans for Accessory Dwelling Units; 2) Objective design standards for residential development projects; and, 3) Standards and processing requirements for adaptive reuse projects (Continued from the April 18, 2024 Planning Commission meeting).

As a follow-up to the previous Commission meeting, the City Planner reminded the Commissioners that objective design standards for multi-family residential projects are among the housing programs required by California law; and, that per the Calabasas General Plan 2021-2029 Housing Element the City has committed to develop and adopt objective design standards. In the presentation, City Planner Bartlett provided examples of objective design standards from the City of Agoura Hills, the City of San Mateo and the Town of Los Gatos.

Speakers: Will Shepphird, Chair of the Architectural Review Panel.

The Commission asked questions of City Planner Bartlett, and of Mr. Shepphird.

Assistant City Attorney Gavin, noted that she and the City Attorney, Matthew Summers, will provide guidance in memo form regarding any types of design standards that could potentially restrict freedom of expression rights under the First Amendment to the U. S. Constitution.

Following discussion, the Commission listed elements of design standards to be studied and considered by the City, including:

- Building articulation, massing and bulk
- Different styles for different zones in the City
- Colors and materials
- Trees and landscaping
- Character and design of outdoor spaces
- Window styles and glazing for retail and other ground-level commercial
- Sustainable design
- Site design standards

Additional architectural and design standards for mixed-use projects

The Commissioners further agreed that input from members of the Architectural Review Panel will be critical in establishing the appropriate design standards.
