# Reports by the Director and Planning Commission:

4. Director's Report:

Director Klein reviewed the upcoming schedule for the Planning Commission to include a new home on Calipatria, that was continued from June 6<sup>th</sup> to the July 18<sup>th</sup> meeting, and a new restaurant on Calabasas Road.

Additionally, Director Klein spoke regarding direction provided by the City Council to planning staff to prepare an ordinance to expand the existing Measure O Open Space protection measures.

The City Council also asked planning staff to prepare an ordinance updating the

sign section of the municipal code. The ordinance would allow digital kiosks to be installed in shopping centers. There will be advertising on the kiosks but also a live feed to the Los Angeles County Sheriff's Department.

# 5. Reports from Members of the Planning Commission:

Vice Chair Harrison spoke regarding an article from the LA Times, that air quality regulators are moving forward to mandate home appliances, to include heating and air conditioning units, to be transitioned to electricity instead of gas.

Commissioner Washburn highlighted that through his participation in the Conejo/Las Virgenes Future Foundation, he learned the City of Thousand Oaks is working on a new 2045 General Plan and is also taking steps to increase affordable housing in the Thousand Oaks community.
