

ACTIVITY REPORT FOR JUNE 2024
CALABASAS**

SCHOOL ISSUES

- All LVUSD schools are currently on summer break. The last day of school was June 12, 2024. The schools will be back in session in mid-August.
- The J-Team is in the process of updating all critical information for all LVUSD schools, information that would be important to have during a critical incident at one of our schools.
- The J-Team is in the process of developing a critical incident training scenario for the staff within LVUSD.
- The J-Team provided security and traffic control at Viewpoint School graduation ceremony.
- The J-Team provided security and traffic control at Calabasas High School graduation ceremony.
- At the request of the District Attorney's Office, The J-Team conducted a follow-up investigation for a battery that occurred between students at AE Wright Middle School.
- The J-Team conducted a criminal threat investigation that occurred at AC Stelle Middle School. The threat was determined to be non-criminal and non-viable. The student and parents were counseled for the incident. All parties were receptive to counseling.

INTERVENTIONS

- The subject involved in A threat at AC Stelle Middle School was counseled along with the parents. We counseled the subject of anger management, the implications of threats, and responsible social media use. All parties were receptive to counseling.
- The subject involved in the vandalism incident at Gelson's Market was counseled along with the parent. All parties were receptive to counseling.

COMMUNITY / CRIMINAL ISSUES

- The J-Team investigated a vandalism incident that occurred at Gelson's in Calabasas. The subject was later detained, counseled, and referred to diversion. The subject and parent were receptive to counseling.
- The J-Team conducted a follow-up investigation for a vandalism incident that occurred in "The Oaks" community. A subject was determined to have committed the vandalism. However, the community HOA was non-desirous of any criminal prosecution.
- The J-Team spoke with numerous citizens and parents who called to question juvenile concerns and community issues. We also provided the parents with resource programs within our community.
- The J-Team contacted the Sylmar Juvenile Court District Attorney to inquire about the investigation and filing of criminal charges against juvenile offenders.
- Throughout the month, we met with Captain Jennifer Seetoo to inform her about our unit's investigations and current issues involving juveniles in our city.
- The J-team entered juveniles into the Youth Diversion Program for various violations.

- The J-Team assisted other investigators in preparing court cases and investigated, prepared, and filed cases with the District Attorney's office.
- The J-Team handled the processing and follow-up of various juvenile referrals regarding various juvenile contacts with uniform personnel brought to the attention of this unit.
- The J-Team conducted normal checks of juvenile problem areas in the city during weekend evenings and responded to juvenile-related calls for service.
- The J-Team aided in patrolling for CARP, filled in for any patrol shortages, and worked mandatory overtime.
- The J-team conducted 290 Residential Verifications for sex registrants within the city of Calabasas jurisdiction.
