RESOLUTION NO. 2024-1921

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA, APPOINTING THE NOMINEES TO THE OFFICE OF CITY COUNCIL AND CANCELING THE CITY'S GENERAL MUNICIPAL ELECTION SCHEDULED FOR TUESDAY, NOVEMBER 5, 2024, PURSUANT TO ELECTIONS CODE SECTION 10229

WHEREAS, on May 22, 2024, the City Council adopted Resolution No. 2024-1899 calling for the holding of a General Municipal Election on Tuesday, November 5, 2024, for the election two City Councilmembers as required by the provisions of the laws of the State of California relating to General Law cities.

WHEREAS, the Notice of Election was published on July 8, 2024.

WHEREAS, the Nomination Period was open from July 15, 2024 through August 9, 2024; and at the close of the nomination period only two candidates were nominated for the two City Council seats.

WHEREAS, Notice of Insufficient Candidates was posted pursuant to law on August 9, 2024, and the City Clerk certified to the City Council that there were not more candidates than offices to be elected.

WHEREAS, Pursuant to California Elections Code Section 10229, since, at the close of the nomination period on August 9, 2024, there were no more candidates than offices to be elected for Councilmember, the City Council can take one of the following actions:

- 1. Appoint to the office the person who has been nominated.
- 2. Appoint to the office any eligible voter if no one has been nominated.
- 3. Hold the election if either no one or only one person was nominated.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CALABASAS AS FOLLOWS:

<u>SECTION 1.</u> Pursuant to Elections Code Section 10229(a)(1), the following persons are appointed to the Office of City Councilmember and are considered to be the same as being elected:

Peter Kraut City Councilmember Four Years
Alicia Weintraub City Councilmember Four Years

<u>SECTION 2.</u> The General Municipal Election scheduled for November 5, 2024 is hereby canceled.

<u>SECTION 3.</u> The persons appointed shall qualify and take office and serve exactly as if elected at a municipal election for the office.

<u>SECTION 4.</u> The City Clerk shall certify to the adoption of this resolution and shall cause the same to be processed in the manner required by law.
