US-101 (Between Liberty Canyon Road and LA City Limits) Incident Report

July 2024

For July of 2024 there were a total of seven reported crashes on US-101. Six of the crashes were property damage only and one crash had injuries. Of those crashes, one involved a hit and run driver. That driver was located and charges were recommended. There were no DUI related crashes. For July of 2023 there were a total of six reported crashes on US-101. Five of the crashes were property damage only and one of the crashes had injuries. Of those crashes, two involved hit and run drivers and one was due to DUI. The hit and run drivers were not located.

August 2024

For August of 2024 there were a total of fourteen reported crashes on US-101. Eleven of the crashes were property damage only and three crashes had injuries. Of those crashes, three involved hit and run drivers and two were due to DUI. The hit and run drivers were not located. For August of 2023 there were a total of sixteen reported crashes on US-101. Seven of the crashes were property damage only and nine crashes had injuries. Of those crashes, one involved a hit and run driver. The hit and run driver was not located. There were no DUI related crashes.

September 2024

For September of 2024 there were a total of twenty-one reported crashes on US-101. Nine of those crashes were property damage only and twelve crashes had injuries. Of those crashes, two involved hit and run drivers and neither driver was located. There were no DUI related crashes. For September of 2023 there were a total of sixteen reported crashes on US-101. Eight of the crashes were property damage only and eight crashes had injuries. Of those crashes, three involved hit and run drivers. The hit and run drivers were not located. There were three DUI related crashes.

Crash Data Comparison to Agoura Hills and Westlake Village (US-101 between Liberty Canyon Road and Ventura County)

- <u>July 2024</u>
 - Five crashes
 - One property damage only
 - Four with injuries
 - One crash involved a hit and run driver and the driver was not located.
 - No DUI related crashes
- August 2024
 - Four crashes
 - One property damage only
 - Three with injuries
 - There were no DUI related crashes and there were no hit and run drivers.
- September 2024
 - Eight crashes
 - Three property damage only
 - Five with injuries
 - There were no DUI related crashes and there were no hit and run drivers.

General Information

- For this reporting period, crashes were caused by unsafe speed for conditions, unsafe turning movements, unsafe lane changes, debris in the roadway, objects falling from vehicles, and DUI.
- For crashes, injuries are described as minor, moderate, or major. Most crashes with injuries involve minor injuries such as complaint of pain or minor abrasions and lacerations.
- There were no fatal crashes for this reporting period.
