

EMERGENCY PREPAREDNESS GUIDE

The Resident Emergency Preparedness Guide book was mailed out to all Calabasas residents this July.



COMMUNITY EMERGENCY RESPONSE TEAM (CERT)



In-person CERT training began Thursday, October 24, 2024 at the Calabasas Community Center. We had 12 participants and all very engaged. Two of



our past PSC commissioners are in the class. See attached flyer for class details.

The Hybrid CERT training was cancelled due to low enrollment.

FIREWISE COMMUNITIES

The city of Calabasas has embraced the NFPA FIREWISE USA program and has developed it's own FIREWISE website at calabasasfirewise.com.



Several communities are participating in the program with several more to come.

SHAKEOUT EARTHQUAKE DRILL – CH and Library participated in the EQ drill on October 17, 2024 and October 25, 2024.



EOC TRAINING

Annual EOC training was Provided on August 12 and 13 to key city staff. EPIC and County fire and sheriff also Participated.



FLU CLINIC

Was provided on September 21 with a total 350 vaccines administered and 135 of those were Covid. Total number of people was 191.



WILDLAND FIRE WEBINAR

The city's annual wildland fire webinar was provided on September 26, 2024. Presentations were made by county fire about the current fire season. Presentations on FIREWISE communities and CERT were also made by city public safety staff and EPIC.

PSPS

PSPS events are becoming more frequent due to the drying of fuels and cyclic Santa Ana wind patterns. PUMPKIN FESTIVAL had a great turnout with the Public Safety and Emergency Preparedness booth and EPIC booth giving out great preparedness information to people who attended.



HAZARD MITIGATION PLAN

The COG MJHMP was approved by FEMA this month. It is available on the city website.

CONTINUITY OF OPERATIONS PLAN (COOP)



The COOP was completed in June 2024. A staff training that was scheduled for June 6, 2024, has been rescheduled for November 2024.

FEMA Public Assistance Grant Program

FEMA project updates have not changed since the last meeting and are as follows:

Over \$500,000 has been obligated to the January 2023 Winter Storms, pending final documents. Waiting for fund reimbursement.

The city is working on the February 2024 storm damages.
