Panel member Dabach moved to approve the project as proposed, but with an added suggestion for the applicant to consider the addition of clearstory windows to introduce more natural light into the interior space, and Panel member Kulkarni seconded the motion. The motion carried 2-0-1, with Panel member Mugrdechian-Armen abstaining because she was not at the previous ARP meeting when the project was originally reviewed.
