Sarah Baisley discussed their house in Old Topanga requiring remediation and her request on August 14, 2024 to delay the receivership with no response.

Dr. Christopher Harz requested help regarding the house his partner Ms. Baisley inherited.

Mayor Pro Tem Kraut moved and Councilmember Albrecht seconded a motion to approve the Consent Calendar. The motion carried unanimously.

## **NEW BUSINESS**

11. Calabasas Community Center Six-Month Operations Update and Recommendations

Community Services Director Green presented the staff report.

In response to Council questions, Community Services Director Green and Deputy Director of Community Services Campbell explained that the Center was below revenue expectations but above anticipated membership; hiring of multiple, part-time, specialized instructors; digital kiosk; incentive to use the daily rate; class flexibility; annual review of suggestions; and concern that package rentals were too expensive.

The Council indicated support for the class pass concept but suggested a different name; and commended staff on efforts to continue improvements. City Manager Meik complimented staff on the data driven results and methodology.

#### MOTION

Mayor Pro Tem Kraut moved and Councilmember Albrecht seconded a motion to receive the Calabasas Community Center Six-Month Operations update and direct staff to bring back appropriate actions to prepare a budget allocation to secure fitness instructors at an annual cost of \$48,048, and update the fee schedule, including proposed changes to both membership fees and facility rental rates at the Calabasas Community Center, with options to reduce non-profit fees. The motion carried unanimously.

12.Introduction of Ordinance No. 2024-409, adding Chapter 3.58 to Title 3 of the Calabasas Municipal Code to Establish an Administrative Remedies Procedure for Challenges to Fees, Charges and Assessments

City Attorney Summers presented the staff report.

#### **MOTION**

Mayor Pro Tem Kraut moved and Councilmember Albrecht seconded a motion to introduce and waive first reading of Ordinance No. 2024-409, adding Chapter 3.58 to Title 3 of the Calabasas Municipal Code to establish an administrative remedies procedure for challenges to fees, charges, and assessments. The motion carried unanimously.

13. Appointment to the Las Virgenes Municipal Water District, Water Supply Reliability and Diversification Study

City Manager Meik presented the staff report.

#### **MOTION**

Councilmember Shapiro moved and Councilmember Albrecht seconded a motion to appoint Mayor Pro Tem Kraut as the Council Liaison/External Committee representative to the Las Virgenes Municipal Water District, Water Supply Reliability and Diversification Study sessions. The motion carried unanimously.

14. Adoption of Resolution No. 2024-1931, Approving Third Amendment to Employment Contract for City Manager

City Attorney Summers presented the staff report.

Mayor Pro Tem Kraut moved and Councilmember Shapiro seconded a motion to adopt Resolution No. 2024-1931 approving the Third Amendment to

Employment Contract for City Manager Kindon Meik. The motion carried unanimously.
