The project was described by Associate Planner Cohen-Cutler. The project owner and/or applicant did not attend the meeting. The Panel expressed concern with the conflicting roof pitches between the addition (3:12), outdoor patio (4:12) and the existing residence (8:12). The addition looks like it is incongruous with the existing residence. The Panel was also concerned about the drainage issues between the intersection of the roof valley with the existing walls. The Panel's recommendation is to increase the roof pitches of the addition to match the roof pitches of the existing residence. This will create a mansard. The Panel also noted that the 9 foot 10 inch plate height could be lowered slightly in order gain more clearance between the new roof and the second story windows. The Panel provided sketches for the applicant as a suggestion to consider. The Panel suggested that the applicant bring back a revised plan to the next meeting.
