Continued Item(s) – 2:40 P.M.:

1. <u>File No. 090006961.</u> A request to demolish the existing Calabasas Inn and construct a new senior facility consisting of 104 independent living residential units and 106 assisted living units with on-site amenities such as an exercise facility, aquatic center, activity rooms, performing art space, kitchen facilities and storage units. This project requires a Conditional Use Permit, Site Plan Review, Oak Tree Permit, Tract Map, and Development Agreement. The proposed four-story building will be 224,818 square-feet, and parking will be located within an above ground parking garage, at 23500 Park Sorrento.

ACTION: The Panel commented that the architectural detailing which was added to the north facing elevation of the garage, the addition of a tower element to the northwest building corner (at the main entrance), and the added color variation adequately addressed previous Panel comments.

The Panel further recommended that architectural detailing similar to what was added to the north elevation of the parking garage be added to the west and south elevations of the parking structure due to the visibility of the west elevation from both Park Sorrento and the office building located to the west, and due to the visibility of the south elevation of the parking structure from the office building located to the south.

Review Item(s) - 3:15 P.M.:

2. <u>File No. 100000309.</u> A request for a Minor Development Permit to renovate the exterior and complete a seismic upgrade to an existing single-family residence located at 3548 Poppy Drive within the Rural Community (RC) zoning district and the Calabasas Highlands (-CH) and Scenic Corridor (-SC) overlay districts.

ACTION: The Panel recommended using a single color (the proposed "sandstone" color) for the stucco rather than a two toned color scheme, and the use of a 20/30 sand finish. The Panel also recommended extending the stonework upward to at least the top of the garage and possibly over the garage, and to include an accent element over the garage. Finally, the Panel suggested adding horizontal screeds (or reveals) to the structure for more architectural interest.
