#### **SUMMARY RECOMMENDATION:**

That the City Council adopt Ordinance No. 2014-311, amending title 17 of the Calabasas Municipal Code to permit fortunetelling as a commercial use within the Commercial Retail (CR) zoning district.

#### **DISCUSSION/ANALYSIS:**

At the February 12, 2014 City Council meeting, Ordinance No. 2014-311 was introduced following a public hearing. It is now the appropriate time for this ordinance to be formally adopted.

Staff recommends that the City Council adopt Ordinance No. 2014-311.

#### **ORDINANCE NO. 2014-311**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA TO AMEND THE CITY OF CALABASAS LAND USE AND DEVELOPMENT CODE **PURSUANT** TO **CALABASAS** MUNICIPAL CODE SECTION 17.76.010 IN ORDER TO PERMIT FORTUNETELLING AS A COMMERCIAL USE IN THE COMMERCIAL RETAIL (CR) ZONING DISTRICT.

WHEREAS, the City Council of the City of Calabasas, California ("the City Council") has considered all of the evidence including, but not limited to, the Planning Commission Resolution, Planning Division staff reports and attachments, and public testimony before making a final decision on February 26, 2014;

WHEREAS, the City Council finds that the Land Use and Development Code Amendment is consistent with the goals, policies, and actions of the General Plan and will not conflict with the General Plan;

WHEREAS, the City Council finds that the Land Use and Development Code Amendment will not be detrimental to the public interest, health, safety, convenience, or welfare of the City;

WHEREAS, the proposed actions are in compliance with the provisions of the California Environmental Quality Act (CEQA) because this project is categorically exempt from environmental review in accordance with Section 21084 of the California Environmental Quality Act (CEQA) pursuant to Section 15061(B)(3) of the CEQA Guidelines.

WHEREAS, the Land Use and Development Code Amendment reflects the input of residents, stakeholders, and public officials; and implements the policies of the 2030 General Plan, is adopted in the public's interest, and is otherwise consistent with federal and state law; and

WHEREAS, the City Council has considered the entirety of the record, which includes without limitation, The Calabasas 2030 General Plan; all reports, testimony, and transcripts from Planning Commission's January 16, 2014 meeting; and reports, and testimony at the City Council's February 12, 2014 meeting.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CALABASAS DOES ORDAIN AS FOLLOWS:

**SECTION 1.** Based upon the foregoing the City Council finds:

- 1. Notice of the February 12, 2014 City Council public hearing was posted at Juan Bautista de Anza Park, the Calabasas Tennis and Swim Center, Gelson's Market and at Calabasas City Hall.
- 2. Notice of the February 12, 2014 City Council public hearings were posted in the *Acorn* ten (10) days prior to the hearings.
- 3. Notice of the February 12, 2014 City Council public hearings included the information set forth in Government Code Section 65009 (b)(2).
- 4. Following a public hearing held on January 16, 2014, the Planning Commission adopted Resolution No. 2014-561 recommending to the City Council approval of File No. 130001639.

**SECTION 2.** In view of all the evidence and based on the foregoing findings, the City Council concludes as follows:

Section 17.76.050(B) Calabasas Municipal Code allows the Planning Commission to recommend and the City Council to approve a Development Code change provided that the following findings are made:

1. The proposed amendment is consistent with the goals, policies, and actions of the General Plan;

The proposed amendment meets this finding because it maintains and strengthens the policies of the General Plan that are intended to preserve a high quality of life. Specifically, one of the goals of the Land Use section of the General Plan is to "provide a distribution of land uses that maintains, yet also enhances the environmental, social, physical and economic well-being of Calabasas" (p. II-1 of the 2030 General Plan). The purpose of this amendment is to ensure that First Amendment rights are protected by providing a reasonable accommodation for fortunetelling uses within the Furthermore, the proposed amendment provides safeguards, such as background investigations of all persons engaging in fortunetelling services, and posting of fees for services, to ensure the preservation of public health and safety.

2. The proposed amendment would not be detrimental to the public interest, health, safety, convenience or welfare of the city;

The proposed ordinance does not contain substantive policy changes that will create a safety hazard or any condition that would negatively impact the

public interest, health or welfare. In contrast, the proposed amendment strengthens the City's ability to preserve a high quality of life for its citizens by focusing such use to the Commercial Retail zone and providing specific standards for fortunetelling use, including the requirement for a background investigation. Therefore, the proposed amendment meets this finding.

3. The proposed amendment is in compliance with the provisions of the California Environmental Quality Act (CEQA).

The proposed amendment is categorically exempt from environmental review in accordance with section 15061(b)(3) of the CEQA Guidelines, General Rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The proposed amendment will not result in additional development opportunities or any foreseeable environmental impact. A Notice of Exemption has been prepared.

4. The proposed amendment is internally consistent with other applicable provisions of this development code.

The proposed amendment identifies fortunetelling as a permitted use in the Commercial Retail zoning district, adds a new section for standards for specific land uses, updates the required parking table and adds a definition for fortunetelling. The proposed amendment does not conflict with any other provision of the Development Code, therefore, this project meets this finding.

**SECTION 3.** Code Amendment. Section 17.11.010 of the Calabasas Municipal Code is hereby amended as follows (pg. 1 on Exhibit A):

In the section labeled "Personal Services" of the table entitled "Table 2-2 Land Use Table", add a new row entitled "Fortunetelling" which shall include a "P" under the column heading "CR" and "17.12.095" under the column heading "See standards in section".

**SECTION 4.** Code Amendment. Section 17.12.095 is hereby added to Title 17 of the Calabasas Municipal Code (pg. 2-3 on Exhibit A):

## "17.12.095 Fortunetelling

When permitted in the zoning district applicable to a site, pursuant to Section 17.11.010 of this Development Code, and consistent with the definition of fortunetelling in this Development Code, all fortunetelling uses are subject to the following provisions.

- A. General Requirements. The following shall apply to all new fortunetelling uses.
  - 1. All persons, whether as agents, assistants, employees or independent contractors, who provide fortunetelling services to another person in a facility or establishment shall, at all times, maintain on the premises all applicable county and state licenses, certificates and permits.
  - 2. Any establishment that provides fortunetelling services shall notify the city in writing at least fifteen (15) days in advance of the effective date of a plan to rename, change management, or convey the business to another person.
- B. Background Investigation. Prior to the filing of a zoning clearance application for any new establishment that provides fortunetelling services, the applicant shall furnish the city with a copy of a California and Federal criminal records background investigation report of the permittee and any person with financial interest in the business; and, consistent with subparagraph A.2, above, a copy of such background check documentation shall also be submitted for any new owner/operator coincidental with the submittal of the required business transfer notification paperwork.
- C. Posting of Fees. The following posting requirements shall apply to all new fortunetelling uses.
  - 1. Each person required to obtain a permit pursuant to this chapter shall post on his or her business premises a sign containing the following information:
    - a. The true name of the fortunetelling practitioner;
    - b. Each service provided by the fortunetelling practitioner;
    - c. The fees charged for each service provided by the fortunetelling practitioner; and
    - d. The statement, "by law, this business is prohibited from charging or soliciting any fee, payment or remuneration beyond these established rates".
  - 2. The sign required by this section shall be prominently posted in the interior of the business premises at a point near the entry and shall be conspicuously visible to every person seeking the services of the fortuneteller. The sign lettering shall be of uniform size with each letter at least one-half inch (1/2") in height.
  - 3. Fortunetelling service may be provided on a temporary basis, at a location other than the fortuneteller's place of business within the Commercial Retail zoning district, if the fortuneteller provides the information required by this section on eight and one-half inch by eleven inch (8 ½" by 11")

paper, in legible print or type. The paper shall also include the name and permanent address of the person(s) providing fortunetelling services. No other information or printed matter shall appear on the paper. A true, correct and complete copy of such paper shall be given to each client prior to providing any fortunetelling services.

- 4. No person shall charge or collect any fee, payment, remuneration, or item of value for fortunetelling services in excess of the fees set forth on a sign or paper required by this section.
- D. Permit Denial or Revocation. The Community Development Director or his or her designee, shall at all times have the power to deny or revoke a permit granted hereunder should the Community Development Director or his or her designee determine:
  - 1. That the permittee has violated any provision of this chapter; or
  - 2. That any information contained in the permit application is false; or
  - 3. That the issuance of the permit was based on fraud, mistake, or any misleading or untrue statements; or
  - 4. That the applicant, permittee, or anyone employed by the permittee has, within seven years preceding an application, been convicted of a violation of Penal Code section 332 or any law involving theft or attempted theft by means of fraud, deceit, use of force, or threats.

**SECTION 5.** Code Amendment. Section 17.28.040 of the Calabasas Municipal Code is hereby amended as follows (pg. 4 on Exhibit A):

In the section labeled "Personal Services" of the table entitled "Table 3-11 Parking Requirements by Land Use", add a new row entitled "Fortunetelling" which shall include "1 space for every 250 sq. ft. of gross floor area" under the column heading "Vehicle Spaces Required" and "5% of vehicle spaces" under the column heading "Bicycle Spaces Required".

**SECTION 6**. Code Amendment. Section 17.90.020.F of the Calabasas Municipal Code is hereby amended as follow (pg. 5 on Exhibit A):

Add the following new definition:

"Fortunetelling" means and includes the telling of fortunes, forecasting of fortunes or futures, or furnishing of any information not otherwise ordainable by ordinary process of knowledge, by means of occult, psychic power, clairvoyance, clairaudience, cartomancy, phrenology, spirits, tea leaves, or other such reading, telepathy, or other craft, art, science, cards, talisman, charm, potion, magnetism, magnetized ordinance or substance, gypsy cunning or foresight, crystal gazing, oriental mysteries or magic, or other similar means, of any kind or nature for any form of consideration.

SECTION 7.	Severability	Clause
------------	--------------	--------

Should any section, clause, or provision of this Ordinance be declared by the Courts to be invalid, the same shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part so declared to be invalid.

# **SECTION 8.** Effective Date:

This Ordinance shall take effect 30 days after its passage and adoption pursuant to California Government Code Section 36937 and shall supersede any conflicting provision of any City of Calabasas ordinance.

# **SECTION 9.** Certification:

The City Clerk shall certify to the passage and adoption of this ordinance and shall cause the same to be published or posted according to law.

Chapter 17.11

- A. Clients shall only be on-site and admitted to the facility between five p.m. and eight a.m.
- B. An interior waiting and intake area shall be provided which contains a minimum of two hundred square feet. No exterior waiting area shall be allowed either onsite or off-site.
- C. Security personnel shall be provided during the hours the emergency shelter is in operation.
- D. Exterior lighting shall be provided for the entire outdoor area of the site consistent with the provisions of Chapter 17.27.

## 17.12.095 Fortunetelling


When permitted in the zoning district applicable to a site, pursuant to Section 17.11.010 of this Development Code, and consistent with the definition of fortunetelling in this Development Code, all fortunetelling uses are subject to the following provisions.

- A. General Requirements. The following shall apply to all new fortunetelling uses.
  - 1. All persons, whether as agents, assistants, employees or independent contractors, who provide fortunetelling services to another person in a facility or establishment shall, at all times, maintain on the premises all applicable county and state licenses, certificates and permits.
  - 2. Any establishment that provides fortunetelling services shall notify the city in writing at least fifteen (15) days in advance of the effective date of a plan to rename, change management, or convey the business to another person.
  - B. Background Investigation. Prior to the filing of a zoning clearance application for any new establishment that provides fortunetelling services, the applicant shall furnish the city with a copy of a California and Federal criminal records background investigation report of the permittee and any person with financial interest in the business; and, consistent with subparagraph A.2, above, a copy of such background check documentation shall also be submitted for any new owner/operator coincidental with the submittal of the required business transfer notification paperwork.
- C. Posting of Fees. The following posting requirements shall apply to all new fortunetelling uses.

- 1. Each person required to obtain a permit pursuant to this chapter shall post on his or her business premises a sign containing the following information:
  - a. The true name of the fortunetelling practitioner;
  - b. Each service provided by the fortunetelling practitioner;
  - c. The fees charged for each service provided by the fortunetelling practitioner; and
  - d. The statement, "by law, this business is prohibited from charging or soliciting any fee, payment or remuneration beyond these established rates".
- 2. The sign required by this section shall be prominently posted in the interior of the business premises at a point near the entry and shall be conspicuously visible to every person seeking the services of the fortuneteller. The sign lettering shall be of uniform size with each letter at least one-half inch (1/2") in height.
- 3. Fortunetelling service may be provided on a temporary basis, at a location other than the fortuneteller's place of business within the Commercial Retail zoning district, if the fortuneteller provides the information required by this section on eight and one-half inch by eleven inch (8 ½" by 11") paper, in legible print or type. The paper shall also include the name and permanent address of the person(s) providing fortunetelling services. No other information or printed matter shall appear on the paper. A true, correct and complete copy of such paper shall be given to each client prior to providing any fortunetelling services.
- 4. No person shall charge or collect any fee, payment, remuneration, or item of value for fortunetelling services in excess of the fees set forth on a sign or paper required by this section.
- D. Permit Denial or Revocation. The Community Development Director or his or her designee, shall at all times have the power to deny or revoke a permit granted hereunder should the Community Development Director or his or her designee determine:
  - 1. That the permittee has violated any provision of this chapter; or
  - 2. That any information contained in the permit application is false; or
  - 3. That the issuance of the permit was based on fraud, mistake, or any misleading or untrue statements; or
  - 4. That the applicant, permittee, or anyone employed by the permittee has, within seven years preceding an application, been convicted of a violation of Penal Code section 332 or any law involving theft or attempted theft by means of fraud, deceit, use of force, or threats.

"Floor area ratio (FAR)" is the ratio of floor area to total lot area. FAR restrictions are used to limit the maximum floor area allowed on a site (including all structures on the site). The maximum floor area of all structures (measured from exterior wall to exterior wall) permitted on a site (including residential carports) shall be determined by multiplying the Floor Area Ratio (FAR) by the total net area of the site (FAR x Net Site Area = Maximum Allowable Floor Area). FAR for non-residential projects shall apply to the gross area of all functional and habitable floors of all structures and shall not apply to supporting parking facilities (open parking lots or structures) which provide required off-street parking in accordance with Section 17.28. Carports and private garages shall be included as part of the FAR for projects located in the Old Topanga and Calabasas Highlands Overlay zones.



"Footcandle" means, for the purposes of Chapter 17.27, a unit of measure for illuminance on a surface that is everywhere one foot, from a uniform point of light of one candle and equal to one lumen per square foot.

"Fortunetelling" means and includes the telling of fortunes, forecasting of fortunes or futures, or furnishing of any information not otherwise ordainable by ordinary process of knowledge, by means of occult, psychic power, clairvoyance, clairaudience, cartomancy, phrenology, spirits, tea leaves, or other such reading, telepathy, or other craft, art, science, cards, talisman, charm, potion, magnetism, magnetized ordinance or substance, gypsy cunning or foresight, crystal gazing, oriental mysteries or magic, or other similar means, of any kind or nature for any form of consideration.

The Controller's website uses data provided to the Controller's Office by cities, counties, and special agencies within the State of California, making it possible to provide custom reports and raw data downloads to website users.

This newly added ability allows citizens to look into compensation payments received by local government and special agency employees and was sparked by the recent discovery of unethical and illegal actions engaged by certain cities within the State.

The purpose for this presentation is to help clarify some of the items recently reported by a local newspaper in this regard and to provide heightened awareness and transparency for the citizens of our city.


# Statistical Reporting Issues with the State Controller's Report


- The State Controller's Report required that cities provide salary and salary related information for each and every employee who received a W-2 (Wage and Tax Statement).
- W-2s are prepared for both Full-time and Part-time employees, regardless of the number of hours worked or the amount of salary received.
- To count a Part-time employee the same as a Full-time employee is not an accurate method for calculating statistical information.
- The number of Full-time equivalent (FTE) employees, based on hours worked, is a much more accurate method for statistical development and comparison.



# State Controller's Report vs. Full-time Equivalent



#### **SUMMARY RECOMMENDATION:**

That the City Council review and discuss information related to a possible change to the City of Calabasas General Municipal Election; and potentially introduce Ordinance 2014-312, amending Calabasas Municipal Code Section 1.04.010, changing the date of the General Municipal Election to the first Tuesday after the first Monday in November of odd-numbered years.

#### **BACKGROUND:**

Per Council direction, staff made preliminary contact with the County of Los Angeles Registrar of Voters' (ROV) office to inquire about impacts on the level of service if the City of Calabasas were to change their election date to the first Tuesday after the first Monday in November of odd-numbered years.

The intent would be to change the date of the City's election and still continue to conduct a standalone election without consolidating onto the Los Angeles County Local and Municipal Consolidated Elections.

ROV staff informed City staff that the change would possibly have an impact on the level of service they could provide as well as create a "concurrent" election scenario that can have other adverse effects.

- Because the Las Virgenes Unified School District (LVUSD) holds their election on the first Tuesday after the first Monday in November of odd-numbered years and the ROV serves as their election official, this would create a situation where two concurrent elections would be conducted on the same day. Meaning that complications may arise from what polling places are used by the City vs. the County. If the same polling places were used, there would need to be two tables and separate election boards with voters needing to go through the process twice. Logistically and from a customer service stand point this is not advisable.
- Vote-by-Mail voting would also present a challenge with voters having to request, receive and return two separate ballots.
- Because the ROV would already be conducting an election for the LVUSD, the
  availability of additional voting devices and other hardware might be limited.
  The County's ability to assist with signature verification and precinct
  consolidation would likely not be impacted. However, a detailed review of every
  service the City requires would need to be conducted to identify any potential
  impacts.
- The change would have a financial impact on the City since the City of Los Angeles currently reimburses the City of Calabasas half the cost of the election for consolidating their Community College District election. The City of Los Angeles has informed staff that if the election date change takes effect, they would continue to hold their elections on the same cycle, March of oddnumbered years.

Based on the logistical and customer service challenges and the potential impact on available resources, it is recommended that the City consolidate its election with the LVUSD.

The ROV again confirmed that they cannot accommodate any consolidation with the Presidential election in November of even-numbered years because there is no capacity on their ballot and voting system. The ROV is currently working to replace their voting systems in hopes of expanding that capacity; however, the change may not occur until past 2018.

The following charter cities have always held their general municipal election in November of even-numbered years:

- Alhambra
- Downey
- Inglewood\*
- Santa Monica
- Pomona

Should the Council desire to proceed with the introduction and ultimate adoption of Ordinance, 2014-312, it would become official only after receiving approval from the Los Angeles County Board of Supervisors.

As directed, attached is an election activity timeline, which also includes some of the legally required actions as a quick reference.

The City of Westlake Village was polled in regard to their consolidation with the LVUSD. Westlake Village also contracts with Martin & Chapman, who coordinates with L.A. County to get the LVUSD Candidates Statements and ballot measure(s) for the ballot. Westlake Village provides preliminary election results to the LVUSD after ballot counting is completed on Election night. The LVUSD is also included in Westlake Village's manual tally of one precinct. Westlake Village does not invoice the LVUSD for election costs. Below are Westlake Village's results for the past two election cycles:

#### 2011:

1,935 ballots cast (includes 938 vote by mail) 5,790 registered voters = 33%

#### 2013:

1,491 ballots cast (includes 841 vote by mail) 6,192 registered voters (first year the VBM surpassed the number of voters at the polls) = 24%

Once the Ordinance is approved, Councilmembers whose terms would expire in March of 2015 would be extended by no more than 12 months. 12 months means the period between the day upon which the term of office otherwise would have commenced and the first Tuesday after the first Monday in November of the odd-numbered year in which the election is held, inclusive.

In addition, the City Clerk would have to cause a notice to be mailed to all registered voters informing the voters of the change in election date. The notice

shall also inform the voters that as a result of the change in election date, the terms of elected City officials currently in office would be changed.

#### **RECOMMENDATION:**

That the City Council review and discuss information related to a possible change to the City of Calabasas General Municipal Election; and potentially introduce Ordinance No. 2014-312, amending Calabasas Municipal Code Section 1.04.010 changing the date of the General Municipal Election to the first Tuesday after the first Monday in November of odd-numbered years.

#### **ORDINANCE NO. 2014-312**

AN ORDINANCE OF THE CITY COUNCIL OF THE OF CITY OF CALABASAS, CALIFORNIA AMENDING THE CALABASAS MUNICIPAL CODE SECTION 1.04.010 CHANGING THE DATE OF THE GENERAL MUNICIPAL ELECTION TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN NOVEMBER OF ODD-NUMBERED YEARS.

WHEREAS, the City of Calabasas currently conducts a general municipal election on the first Tuesday after the first Monday in March of odd-numbered years; and

WHEREAS, the local school district conducts elections on the first Tuesday after the first Monday in November of each odd-numbered year pursuant to Elections Code section 1302; and

WHEREAS, Elections Code section 1301(b) authorizes the City to conduct, subject to approval by the Board of Supervisors, the general municipal election on the same day as the school district election; and

WHEREAS, Pursuant to Elections Code section 1000(d) the city has the option to hold its general municipal election on the first Tuesday after the first Monday in November of odd numbered years; and

WHEREAS, the City desires to change its general municipal election date to coincide with the school district election in an effort to increase voter participation in local elections.

**NOW THEREFORE**, the City Council of the City of Calabasas, California, does hereby ordain as follows:

**SECTION 1.** Section 1.04.010 of the Calabasas Municipal Code is hereby amended to read as follows:

#### 1.04.010 **ELECTION DATE.**

General municipal elections shall be conducted on the first Tuesday after the first Monday in November of odd-numbered years.

**SECTION II. SEVERABILITY.** If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining

sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases of this Ordinance, or its application to any other person or circumstance. The City Council of the City of Calabasas hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that any one or more other sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable.

**SECTION III. EFFECTIVE DATE.** This ordinance shall take effect only after both thirty days have elapsed after its adoption and upon approval by the Los Angeles County Board of Supervisors.

**SECTION IV. CERTIFICATION**. The City Clerk shall certify to the passage and adoption of this ordinance and shall cause the same to be published or posted according to law and transmitted to the Board of Supervisors for consideration.
