Notice of Intent to adopt a Negative Declaration / Mitigated Negative Declaration

NOTICE IS HEREBY GIVEN that the City of Calabasas has completed an Initial Study for the following project in accordance with the City's Guidelines implementing the California Environmental Quality Act:

Project Title/File No.: Viewpoint School Tennis Courts and Parking Lots Project, 140001413

Project Location: 23238 Mulholland Highway (Peters residential parcel), 23604 Dry Canyon Cold Creek

Road (Brown residential parcel), 23602 Dry Canyon Cold Creek Road (Castle Oaks

residential parcel) and 23620 Mulholland Highway (Viewpoint Campus).

Project Description: The proposed Viewpoint School Tennis Courts and Parking Lots project (proposed

project) includes the re-development of three sites (Peters, Brown and Castle Oak) that would become part of the school campus property. Improvements to the sites include installation of six tennis courts and an accessory building, additional campus parking in three areas, and the renovation of two existing residential structures. One renovation would accommodate offices for school administration and the other renovation would provide a primary residence to the school principal. The project would remove the Peters property building and appurtenant structures, redevelop the interior of the Castle Oaks property to accommodate the administrative offices, and update the Brown residence to accommodate the principal's primary residence.

Project Sponsor: Viewpoint School, 23620 Mulholland Highway, Calabasas, CA 91302

This Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. On the basis of such Initial Study, the City's staff has concluded that the project will not have a significant effect on the environment, and has, therefore, prepared a Draft Mitigated Negative Declaration.
